The City Manager or designee is hereby authorized to enter 15 an agreement with MCKESSON to furnish and deliver as-needed medical-surgical 16 supplies and pharmaceuticals, of the same type and kind identified in the SOURCEWELL 17 Contract except as modified by mutual agreement of the City and MCKESSON, and the purchase by the City shall be on the same terms and conditions afforded to the STATE 18 19 OF MINNESOTA local government unit and service cooperative in an annual amount not to exceed Two Hundred Seventy Five Thousand Dollars (\$275,000), until the State of 20 21 Minnesota contract expires on April 30, 2026, with the option to renew an additional one 22 year period, at the discretion of the City Manager.
