

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH, AMENDING RESOLUTION NO. C-22526 AS PREVIOUSLY AMENDED TO ESTABLISH AND REVISE FEES FOR SERVICES RENDERED BY THE LONG BEACH FIRE DEPARTMENT

WHEREAS, the City Council of the City of Long Beach adopted Resolution No. C-22526 on June 13, 1978, establishing fees for services rendered by the Long Beach Fire Department; and

WHEREAS, Resolution No. C-22526 was amended by Resolution No. C-23138 on April 7, 1981, by Resolution No. C-23629 on November 1, 1983, by Resolution No. C-24430 on September 1, 1987, by Resolution No. C-25056 on June 11, 1991, by Resolution No. C-27410 on September 15, 1998, by Resolution No. C-27899 on September 4, 2001, by Resolution No. C-28078 on September 10, 2002 and by Resolution No. C-28246 on September 16, 2003; and

WHEREAS, it appears reasonable and necessary to again amend Resolution No. C-22526, as amended, with respect to the Fee Schedule provided in that Resolution;

WHEREAS, prior to adoption of this resolution revising the schedule of fees, public notice and hearing have been given in accordance with Section 66018 of the California Government Code.

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. Resolution No. C-22526, adopted by the City Council on June 13, 1978, as amended, is further amended by amending the Fee Schedule attached to this resolution and incorporated by reference herein as Exhibit "A".

**MISCELLANEOUS PERMITS**

**FEEES**

Fees listed below are based on current salaries and equipment costs, and are subject to yearly adjustments based on the City's annual salary resolution and equipment cost.

**MS-01 Reinspections**

- A. Reinspection, as a result of requested inspection not canceled a minimum of two hours or more prior to established appointment time, or not ready for inspection and/or test upon arrival of the Fire Department representative ... 320.00
- B. Reinspection, as a result of items PC-01 through PC-11, SA-03 and SA-04 not passing on-site acceptance inspection, \$44.00 per hour per required/needed Fire Department representative with a minimum of 15 minutes ..... 290.00

**MS-02 Stand-by Fire Prevention or Marine Safety Watch:**

- A. Fire Prevention (minimum billing of four hours per event)..... \$70/per/hr
- B. Marine Safety – Land (minimum billing of four hours per event)..... \$60/per/hr
- C. Marine Safety – Water (minimum billing of four hours per event) ..... \$210/per/hr

**MS-03 Fire Department Equipment with Crew – standby time utilizing in-service units for a maximum of one hour. A security deposit is required when a standby fire suppression unit with personnel is required by the Fire Chief or Fire Marshal, or when requested. The deposit shall be \$370.00, which will cover one hour of such standby. This Check will be refunded in full if the standby fire suppression unit with personnel is not required and/or at the scene for more than fifteen (15) minutes..... 370.00**

**MS-04 Fire Department Equipment with Crew – required or requested standby time utilizing “Call-back” personnel, for each fire suppression unit with personnel shall be:**

- A. Rescue ambulance \$32.00 per day plus \$76.00 per hour for each of two paramedics. Minimum billing of four hours..... 640.00+
- B. Fire engine \$84.00 per day plus \$76.00 per hour for each of four crew members. Minimum billing of four hours ..... 1,300.00+
- C. Ladder truck \$124.00 per day plus \$76.00 per hour for each of four crew members. Minimum billing of four hours ..... 1,340.00+

**MS-05 Copies of report and documents**

The Fire Department shall charge and collect the fees for the duplication of any record, paper, or instrument in an amount consistent with applicable state law.

**MS-06 Overnight stay without fire watch 0 – 299 persons ..... 180.00**
