SECOND AMENDMENT TO AGREEMENT NO. 34652

THIS SECOND AMENDMENT TO AGREEMENT NO. 34652 is made and entered, in duplicate, as of July 6, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on May 23, 2017, by and between ZONAR SYSTEMS, INC, a Washington corporation ("Contractor"), with a place of business at 18200 Cascade Ave. S #200, Seattle, Washington 98188, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34652 ("Agreement") whereby Contractor agreed to provide Zonar electronic vehicle inspection and tracking components including monitoring services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to July 21, 2020;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 3 of the Agreement is hereby amended to read as follows:  
"3. The term of this Agreement shall commence at midnight on July 22, 2017, and shall terminate on July 21, 2021 unless sooner terminated as provided herein. The City has the option to terminate this Contract by giving thirty (30) days prior notice of termination to Contractor."

2. Except as expressly amended herein, all terms and conditions in Agreement No. 34652 are ratified and confirmed and shall remain in full force and effect.






