THIRD AMENDMENT TO AGREEMENT NO. 35983
35983

THIS THIRD AMENDMENT TO AGREEMENT NO. 35983 is made and entered, in duplicate, as of April 14, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 21, 2019, by and between THE NONPROFIT PARTNERSHIP, a California nonprofit organization ("Consultant"), with a place of business at 4900 East Conant Street, Building 02, Suite 225, Long Beach, California 90808, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with providing training and technical assistance support to 30 City of Long Beach nonprofits ("Project"); and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35983 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to amend the scope of work and budget;

WHEREAS, the Parties entered into a Second Amendment to extend the term of the contract and increase the contract amount by Three Thousand Two Hundred Sixty-Two Dollars (\$3,262) for a new total amount contract of Eighty-Eight Thousand Eight Hundred Sixty-Two Dollars (\$88,862); and

WHEREAS, the Parties currently desire to extend the contract for an additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2. of the Agreement is hereby amended to read as follows.

"The term of this Agreement shall commence at midnight on July 1, 2021, and shall terminate at 11:59 p.m. on March 31, 2023, unless sooner terminated as provided

1 in this Agreement, or unless the services or the Project is completed sooner. This
2 Agreement shall not be extended past May 21, 2024 without authorization of the City
3 Council.”

4 2. Except as expressly modified herein, all of the terms and conditions
5 contained in Agreement No. 35983 are ratified and confirmed and shall remain in full force
6 and effect.
