

**Emergency Proclamation to Address Homelessness Update 12** 

**City Council Meeting – June 20, 2023** 



To reduce the number of persons experiencing homelessness in the City and the region by increasing housing opportunities and by enhancing current initiatives that provide field-based outreach, engagement, and supportive services while maintaining the safety and security of the people experiencing homelessness, the general public and staff, and improving overall public safety for the entire community.



## Homelessness Strategic Plan

- The Statement of Possibility from the Everyone Home Homelessness Strategic Plan continues to define success in Long Beach in its mission to end homelessness.
- Statement of Possibility: The experience of homelessness in Long Beach is rare and brief when it occurs.







#### **Increase access to services**

- The Mobile Access Center (MAC) schedule for June was released and will operate Monday through Friday with varied hours and locations (<u>https://longbeach.gov/homelessness/home</u> <u>less-services/</u>)
- Opened new Queensway site and participants have transitioned to the new site

# Engage Community in data, planning and assistance

- Refreshed existing data elements on Homelessness Emergency Dashboard
- Conducted residential and business outreach related to the June 13 Council Item on the City's purchase of the Long Beach Rescue Mission
  - o Canvassed 42 Businesses
  - Engaged 8 Community Partners (neighborhood associations and nonprofits)
  - Letters were mailed to residents who live within 200 ft of the property





#### **Build capacity to address homelessness crisis**

• The Intergovernmental Work Group has identified leads to coordinate the various "policy pathways" and drafted a framework to guide the City's work as it relates to prevention policy



## Increase interim and long-term housing access

- Council approved the purchase of 702
   W. Anaheim to be used for a permanent year-round shelter and as the annual Winter Shelter for people experiencing homelessness
- Received \$6.5 million from LA County to support the purchase and rehabilitation of the building.

#### **Increase access to services**

- Continue partnership conversations with LA County Department of Health Services and Los Angeles Homeless Services Authority (LAHSA) including discussion of Service Area 8 presence at the MSC
- Increase outreach and education regarding availability of the RV Sanitation and Water Filling site
- Housing Authority will continue to work to update its Housing Choice Voucher List



#### Engage community in data, planning and assistance

- Finalize planning for the Interfaith Convening, scheduled for Thursday, June 22 at Grace Long Beach, with faith-based organizations across the City who are committed to supporting the efforts of not only the emergency response, but ongoing after the emergency has been lifted
  - Topics include:
    - The State of Homelessness in Long Beach
    - Faith Community & Homeless Services
    - Counseling and Programming
    - Increasing Shelter Sites and Partnering with Services Providers
    - Increasing Access to Food Resources
    - Faith Community and Prevention
    - Housing Production on Faith Land
    - Renters Rights, Organizing and Policy Advocacy
- Preparing data dashboard update to include homeless count data to release on July 6

#### Build capacity to address the homeless crisis

- Continue evaluating Port of Long Beach and other properties that can support additional homelessness services
- City staff met with Long Beach City College on June 15th to discuss opportunities for partnership and furthering support for additional homelessness services



#### Increase interim and long-term housing access

- Finalize contracts with Rescue Mission for the 702 W Anaheim Site for the longterm interim shelter
- Continue to work to finalize plans, permitting, and construction agreements to commence construction activities on City-led capital improvements at the Multi-Service Center (Tiny Homes), Navigation Center, Best Western, and Luxury Inn.
