Raul Añorve – First term through July 2025

Raul Añorve is a Council District 9 resident. Raul Works as a Paralegal for the Los Angeles City Attorney's Office, Safe Neighborhoods & Gang Division. Duke Givens is a long Beach native who grew up in the 6th district. He attended Long Beach Poly High School and Long Beach City College where he was inducted into the Hall of Fame. Duke has served in the United States Airforce during the Desert Storm Conflict and was honorably discharged. Duke is the founder of the Care Closet LBC, a nonprofit helping our people experiencing homelessness in Long Beach.
