3 THIS FIRST AMENDMENT is made and entered, in duplicate, as of May 13,
4 2007, for reference purposes only, pursuant to a minute order adopted by the City
5 Council of the City of Long Beach at its meeting held on May 2, 2006, by and between
6 INTERCEPT, INC., a California corporation ("Consultant"), whose business address is
7 4201 Wilshire Boulevard, Suite 312, Los Angeles, California 90010, and the CITY OF
8 LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires polygraph testing services and analysis
10 requiring unique skills to be performed in connection with pre-employment background
11 checks and other law enforcement activities; and

12 WHEREAS, in May of 2006, City and Consultant entered into Agreement
13 No. 29930 for Consultant to provide City with polygraph testing services; and

14 WHEREAS, City desires to exercise its option and renew the term of the
15 Agreement for an additional year;

16 NOW THEREFORE, in consideration of the mutual terms and conditions in
17 Agreement No. 29930, the parties agree as follows:

18 Section 2 of the Agreement is deleted in its entirety and amended to read:

19 "2. TERM. The term of this Agreement shall commence at midnight on
20 May 11, 2007 and shall terminate at 11:59 p.m. on May 10, 2008, unless sooner
21 terminated as provided in this Agreement. City shall have the right to exercise one (1)
22 option to extend the agreement for an additional year by providing written notice to
23 Consultant of its intention to exercise said option thirty (30) days in advance of the
24 expiration of the then-current term of this Agreement."

25 Except as expressly amended herein, all of the terms and conditions in
26 Agreement No. 29930 are ratified and confirmed and shall remain in full force and effect.
