

1 SECOND AMENDMENT TO AGREEMENT NO. 32016

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 32016 is made and
4 entered, in duplicate, as of December 3, 2013 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April
6 23, 2013, by and between URS CORPORATION WHICH WILL DO BUSINESS IN
7 CALIFORNIA AS URS CORPORATION AMERICAS, a Nevada corporation, with a place
8 of business at 915 Wilshire Boulevard, Suite 700, Los Angeles, California 90017
9 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, the City requires specialized services requiring unique skills to
11 be performed in connection with As-Needed Engineering Consulting Services; and

12 WHEREAS, the parties entered Agreement No. 32016 whereby Consultant
13 agreed to provide these Services; and

14 WHEREAS, the parties desire to increase the Agreement amount by
15 \$300,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the parties agree as follows:

18 1. Section 1.A of Agreement No. 32016 is hereby amended to read as
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, not to exceed One Million Three
25 Hundred Thousand Dollars (\$1,300,000), at the rates or charges shown in Exhibit
26 "B".

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Agreement No. 32016 are ratified and confirmed and shall remain in full
