THIRD AMENDMENT TO AGREEMENT NO. 35574
35574

THIS THIRD AMENDMENT TO AGREEMENT NO. 35574 is made and entered, as of April 5, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 12, 2020, by and between FARWEST CORROSION CONTROL COMPANY, a Texas corporation ("Consultant"), with a place of business at 12029 Regentview Avenue, Downey, California 90241, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35574 (the "Agreement") whereby Consultant agreed to provide as-needed on-call professional engineering and inspection services for a period of one (1) year, with the option to renew for four (4) additional one-year periods, at the discretion of the City Manager; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to June 30, 2022; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to June 30, 2023; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:
"2. TERM. The term of this Agreement shall commence at midnight on July 1, 2020 and shall terminate at 11:59 p.m. on June 30, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for one (1) additional one-year period, at the discretion of the City Manager."
2. The rates/charges in Exhibit "B" attached to the Agreement are hereby

1 amended and replaced with Exhibit "B-1", attached hereto and incorporated herein.

2 3. Except as expressly modified herein, all of the terms and conditions
3 contained in Agreement No. 35574 are ratified and confirmed and shall remain in full force
4 and effect.

6 executed with all formalities required by law as of the date first stated above.

ALL RATES ARE SUBJECT TO A FOUR (4) HOUR MINIMUM

The above rates DO NOT apply for Prevailing Wage or Davis Bacon Labor requirements. Rates for these types of projects will be quoted on a case-by-case basis and subject to the requirements of the project and local jurisdiction.

*Industry standard instruments, tools and equipment are provided with our engineering personnel at the hourly rate indicated. Specialized equipment, depending on the type, will be provided at additional cost to the customer and pricing will be provided prior to start of the project.

All rates apply to work and travel and are based on an 8-hour standard day, Monday through Friday. Travel time and mileage is charged from our office to and from the jobsite. All time over 8 hours per day, Monday through Friday, shall be charged at 1.25 times the normal rate. Work scheduled beyond normal business hours, such as night work, shall be charged at 1.25 times the normal rate. Saturday, first 8 hours are 1.25 times the normal rates. All Saturday time over 8 hours, Sundays and holidays are billed at 1.5 times the normal rate.
