SECOND AMENDMENT TO AGREEMENT NO. 34193

34193

THIS SECOND AMENDMENT TO AGREEMENT NO. 34193 is made and entered, in duplicate, as of March 9, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on November 18, 2014, by and between OUTFRONT DECAUX STREET FURNITURE LLC, a limited liability company ("Outfront Decaux"), formerly known as CBS DECAUX STREET FURNITURE LLC, with a place of business at 405 Lexington Avenue, New York, New York 10174, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Outfront Decaux (the "Parties") entered into Agreement No. 34193 (the "Agreement") whereby Outfront Decaux agreed to construct and maintain ad-bearing bus shelters; and

WHEREAS, the Parties entered into the First Amendment through an executed correspondence dated February 26, 2019, to provide all services as described in the Agreement for two newly installed City-owned ad-bearing shelters at (1) the Northwest Corner of Willow Street and Magnolia Avenue, and (2) the Northwest Corner of Harding Street and Atlantic Avenue; and

WHEREAS, the Parties desire to extend the term of the Agreement by one (1) additional five-year term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2.A. of the Agreement is hereby amended to read as follows:

"A. This Agreement shall begin at 12:01 a.m. on August 1, 2015 and shall end at midnight on July 31, 2025."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34193 are ratified and confirmed and shall remain in full force and effect.
