## THIRD AMENDMENT TO PERMIT NO. 28891

THIS THIRD AMENDMENT TO PERMIT NO. 28891 is made and entered, in duplicate, as of July 1, 2007 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 7, 2007, by and between the STATE OF CALIFORNIA, DEPARTMENT OF REHABILITATION, BUSINESS ENTERPRISE PROGRAM ("State") and the CITY OF LONG BEACH ("City").

WHEREAS, the City and the State entered Permit No. 28891 (as amended, the "Permit") whereby State agreed to operate and maintain or cause to be operated and maintained a food concession including a dining area for City's employees and guests at the lower level of City Hall located at 333 West Ocean Boulevard, Long Beach, California ("Permit Area"); and

WHEREAS, the parties desire to, among other things, extend the term of the Permit;

NOW, THEREFORE, in consideration of the terms and conditions in the Permit, the parties agree as follows:

- 1. Section 2 of the Permit is hereby amended in its entirety to read as follows:
- "2. Term. The term of this Permit shall commence at midnight on July 1, 2004, and shall terminate at 11:59 p.m. on June 30, 2010, unless sooner terminated as provided herein. The City, at the City Manager's sole discretion, may extend this Permit for one (1) additional period of two (2) years by giving notice of its intent to extend on or before June 30, 2010. However, the terms of this Permit may be subject to modification upon extension."
- The State shall cause the Operator (as defined in the Permit) to refrain from using any expandable polystyrene (also known as Styrofoam) products in the Permit Area.
  - 3. The City, at the City Manager's sole discretion, may temporarily
