3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35025 is made and
4 entered, in duplicate, as of June 4, 2019, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on June 12,
6 2018, by and between THE BROADBAND GROUP, a Nevada corporation ("Consultant"),
7 with a place of business at 900 South Pavilion Center Drive, Suite 155, Las Vegas, Nevada
8 89144, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 35025 (the "Agreement") whereby Consultant agree to provide Citywide fiber network
11 implementation planning; and

12 WHEREAS, the Parties desire to extend the term of the Agreement one (1)
13 additional one-year period;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 2 of the Agreement is hereby amended to read as follows:

17 "2. TERM. The term of this Agreement shall commence at midnight on
18 June 12, 2018, and shall terminate at 11:59 p.m. on June 12, 2020, unless sooner
19 terminated as provided in this Agreement, or unless the services or the Project is
20 completed sooner."

21 2. Except as expressly amended herein, all terms and conditions in
22 Agreement No. 35025 are ratified and confirmed and shall remain in full force and effect.
