DISCUSSION

At the August 7, 2007 City Council meeting, Sixth District City Councilmember Dee Andrews, First District Vice Mayor Bonnie Lowenthal, and Seventh District Councilwoman Tonia Reyes Uranga requested that the California Recreation Center be named in honor of Ernest Samuel McBride, Sr. (Attachment #1). According to Administrative Regulation AR 8 – 7, the City Council referred the request to the Housing and Neighborhoods Committee and the Parks and Recreation Commission.

The Parks and Recreation Commission considered this request at their August 16, 2007 meeting (attachment #2) and unanimously approved this request.

The Administrative Regulations AR 8 – 7 applies to the naming of all public land, buildings and facilities. AR 8 – 7 provides several policies to guide the consideration of a naming request. The following are those policies:

- The name should incorporate Long Beach whenever important for civic recognition or identification;
- A name in honor of a recognized geographic area, a topographic feature or a historically significant event may be appropriate;
- A name in honor of persons or families who have donated the land or a substantial portion of the improvement costs may be appropriate when applicable;
- A name in honor of a person or persons who have served the nation, the State of California, and/or the City of Long Beach in an exceptional or distinguished manner may be appropriate if warranted by service of major significance;
- A name in honor of a living person, or of a deceased person within one year of their death, is not appropriate, unless the significance of that person's contribution is worthy of an exception to the policy;
- A name in honor of a person is not appropriate when a name in honor of another person has been given to the same site, building or facility in the past;
- A name in honor of a person is not appropriate if that person has been overly recognized in the past; and,
- A name may be selected through a competition or a contest.

Naming the park after Ernest Samuel McBride, Sr. is appropriate under the category of persons who have served the nation, the State of California, and/or the City of Long Beach in an exceptional or distinguished manner of major significance. Ernest Samuel McBride, Sr. was a local leader and civil rights pioneer who worked endlessly to end discrimination in housing, schools, and the workplace.

Finally, AR 8-7 recommends that there be a one-year period between the death of a person and the naming of a facility in their honor. This is intended to provide a time of reflection so that something is not named for someone that does not deserve the honor out of the emotions of the grieving period. In this case, the obvious achievements of Ernest Samuel McBride, Sr. make the need for a period of reflection unnecessary and warrant an exception to that guideline.

TIMING CONSIDERATIONS

City Council action on this matter is not time critical.

FISCAL IMPACT

There is no fiscal impact with the recommended action.

IT IS RECOMMENDED THAT THE COMMITTEE:

Concur with the recommendation that renaming California Recreation Center in honor of "Ernest Samuel McBride, Sr." is appropriate and refer the recommendation to the City Council for approval.

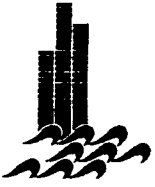

**Subject:** Recommendation regarding "Ernest S. McBride, Sr. Park" as the Potential Name for California Recreation Center

The action before the Parks and Recreation Commission is to recommend a name for California Recreation Center to honor a local leader and civil rights pioneer, Ernest S. McBride, Sr.

**Background.** On August 7<sup>th</sup>, Vice Mayor Bonnie Lowenthal, Sixth District City Councilmember Dee Andrews, and Seventh District Councilwoman Tonia Reyes Uranga requested that California Recreation Center be re-named the "Ernest S. McBride, Sr. Park." According to Administrative Regulation AR 8-7, the City Council has referred the request to its Housing and Neighborhoods Committee, and to the Parks and Recreation Commission for recommendations on that name. The Parks and Recreation Commission recommendation will be transmitted to the Housing and Neighborhoods Committee before it acts on the naming.

The Administrative Regulations AR 8-7 applies to the naming of all public land, buildings and facilities. AR 8-7 provides several policies to guide the consideration of a naming request. The following are those policies:

- The name should incorporate Long Beach whenever important for civic recognition or identification;
- A name in honor of a recognized geographic area, a topographic feature or a historically significant event may be appropriate;
- A name in honor of persons or families who have donated the land or a substantial portion of the improvement costs may be appropriate when applicable;
- A name in honor of a person or persons who have served the nation, the State of California, and/or the City of Long Beach in an exceptional or distinguished manner may be appropriate if warranted by service of major significance;
- A name in honor of a living person, or of a deceased person within one year of their death, is not appropriate unless the significance of that person's contribution is worthy of an exception to the policy;
- A name in honor of a person is not appropriate when a name in honor of another person has been given to the same site, building or facility in the past;
- A name in honor of a person is not appropriate if that person have been overly recognized in the past; and,
- A name may be selected through a competition or a contest.

Naming the park site after Ernest S. McBride, Sr. is appropriate under the category of persons who have served Long Beach in an exceptional or distinguished manner of major significance. Mr. McBride was the co-founder of the Long Beach Branch of the National Association for the Advancement of Colored People (NAACP) and a long-time local leader and civil rights pioneer who worked endlessly to end discrimination in housing, schools, and the work place in the City of Long Beach.

**Discussion.** Referring back to the naming policies in AR 8-7, the name of Ernest S. McBride, Sr. Park is appropriate, as it honors an exceptional career of service to the community. Mr. McBride moved to California in 1930, and settled in Long Beach in search of a better life free from segregation and discrimination. He discovered that Long Beach was almost as bad as the two states he left, Mississippi and Arkansas, but he decided to stay and begin his lifelong fight for improvement in race relations in this city. Mr. McBride married Lillian Maria Veal in 1934. In 1940, Mr. and Mrs. McBride, along with three others, decided to form the local chapter of the NAACP.

The couple experienced difficulty finding a home in Long Beach's tiny black neighborhood until they finally purchase a home in 1948 on Lemon Avenue. The family home became the meeting ground for protest plans, and headquarters for one of Long Beach's first Neighborhood Watch organizations. The first meetings of the local chapter of the NAACP were held in this home before moving to local churches, and then to California Recreation Center where meetings are still held today. In 1994, the Cultural Heritage Commission and the Long Beach City Council designated the McBride home, at 1461 Lemon Avenue, a historical city landmark.

Mr. McBride was a field secretary and founder of the Anti-Discrimination Committee. This committee worked tirelessly to get more African Americans hired as police officers, firemen, as well as in other civil service jobs. He was instrumental in getting the General Telephone Company to hire its first black Accounting Clerk. He was an advocate for workers' rights. Mr. McBride received numerous certificates or appreciation, recognition, and commendation from local, state, and federal leaders throughout his distinguished life.

Finally, AR 8-7 recommends that there be a one-year period between the death of a person and the naming of a facility in their honor. This is intended to provide a time of reflection so that something is not named for someone that does not deserve the honor out of the emotions of the grieving period. In this case, the obvious achievements of Mr. Ernest S. McBride, Sr. make the need for a period of reflection unnecessary and warrant an exception to that guideline.

It is recommended that the Parks and Recreation Commission recommend to the Housing and Neighborhood Committee, and the full City Council that California Recreation Center be renamed "Ernest S. McBride, Sr. Park."

Dear Mr. Hester:

We are requesting to have California Avenue Recreation Center renamed Ernest Samuel McBride Sr. Center in honor of our father.

Ernest passed away on May 5<sup>th</sup> 2007. He was one of Long Beach's most prominent civil rights pioneers and community activist. He was a tireless crusader for civil rights and an icon in the 6<sup>th</sup> District.

After suffering much racial discrimination in Mississippi and Arkansas, he became fed up and decided to move to Long Beach, California in 1930. He discovered Long Beach was almost as bad as the two states he left. Mr. McBride decided to stay and begin his lifelong fight for improvement in race relations in this city. In 1940, McBride and his wife Lillian along with three other people decided to form the local chapter of the National Association for the Advancement of Colored People (NAACP). He recalled how tough it was to recruit members because at the time people were afraid to join for fear of reprisals. The meetings were held in his home, then to the local churches and presently to California Avenue Recreation Center. Mr. McBride continued to recruit members and to fight for human rights and equality for all. He and his family received constant threats of violence, if they didn't leave town but Ernest fought on. He continued to organize protest marches. At times he used his children to march on picket lines. He led NAACP negotiations with the City of Long Beach to hire minorities. From 1943 to 1948, he held constant talks with the Long Beach Police Department, protesting police brutality and the vagrancy laws and the need for black officers. He was instrumental in stopping school districts from having minstrel shows in 1946. In 1953, he organized a protest march that lasted over nine months, which ended with the store hiring black cashiers. He spearheaded talks with the city civil service department to hire minorities in better paying jobs. He wrote letters to California's Lt. Governor Anderson protesting restrictive covenant clauses in home buying contracts; used to prevent blacks from buying homes throughout Long Beach. He was instrumental in getting the General Telephone Company to hire its first black Accounting Clerk. Mr. McBride wrote letters to President Franklin D. Roosevelt protesting the refusal of the Electrician's Union at the Naval Dry Docks to allow blacks to join, even at the risk of losing his own job. While serving on the Public Safety Advisory Commission he played a key role in the formation of the Citizens Police Review Board. This is only some of the many accomplishments our father has made.

Our family along with others thinks it befitting that the California Avenue Recreation Center be renamed in his honor. He was one of Long Beach's local heroes, who dedicated his life to integrating this city for the betterment of all. We have enclosed a partial list of some of the awards he has received.

**WHEREAS**, It was with immense sadness and a deep sense of loss that word was received of the death, at age 97, of Ernest McBride, Sr., a truly remarkable individual whose indomitable spirit, forthright and honest demeanor, and fine personal example were an inspiration to those people whose lives he touched; and

**WHEREAS**, A tireless crusader for civil rights and an icon in Long Beach black history, Ernest McBride was co-founder of the Long Beach Chapter of the NAACP, through which he committed himself to end discrimination in housing, schools, and the workplace; and

**WHEREAS** Born on November 12, 1909, in Carrollton, Mississippi, one of nine children of a Mississippi Delta farmer, Ernest McBride relocated to Arkansas

**WHEREAS**, It was with immense sadness and a deep sense of loss that word was received of the death, at age 97, of Ernest McBride, Sr., a truly remarkable individual whose indomitable spirit, forthright and honest demeanor, and fine personal example were an inspiration to those people whose lives he touched; and

**WHEREAS**, A tireless crusader for civil rights and an icon in Long Beach black history, Ernest McBride was co-founder of the Long Beach Chapter of the NAACP, through which he committed himself to end discrimination in housing, schools, and the workplace; and

**WHEREAS**, Born on November 12, 1909, in Carrollton, Mississippi, one of nine children of a Mississippi Delta farmer, Ernest McBride relocated to Arkansas with his family, where he attended a segregated school and experienced discrimination throughout his childhood and early adult years; and

**WHEREAS**, In search of a better life, Ernest McBride moved to California in 1930 and settled in Long Beach, where he took his first job as a member of an all-black crew loading cotton in the Port of Long Beach; upon learning that his crew had been hired to replace Latinos who had been fired after they asked for a raise (the Latinos had been paid 50 cents an hour and McBride and his co-workers were paid 45 cents), he quit in protest and took a job shining shoes; and

**WHEREAS**, In Long Beach, Ernest McBride met the love of his life and a partner in the fight for civil rights, Lillian Marie Veal, and they were married in 1934 and were blessed with six children; and

**WHEREAS**, The young couple experienced difficulty finding a house in Long Beach's tiny black neighborhood and faced discrimination in other area neighborhoods and, after living in Wilmington for two years, Ernest and Lillian purchased a home in 1948 on Lemon Avenue, and the neighborhood soon grew to become one of the first middle-class black neighborhoods in Long Beach; and

**WHEREAS**, The family home became a meeting ground for protest plans and a headquarters for one of Long Beach's first Neighborhood Watch organizations and, in addition, Ernest McBride was a field secretary and founder of the Anti-Discrimination Committee, while Lillian was the NAACP chapter's secretary; and

**WHEREAS**, Ernest McBride's committee worked to get more African-Americans hired as police officers and firemen and in other civil service jobs, and he was an advocate for workers' rights and worked with labor unions, even though he was not a member himself; and

**WHEREAS**, Ernest McBride worked for Ralph's Grocery Co. and several other employers while he and Lillian and other activists quietly worked for equality; and

**WHEREAS**, In 1994, the Cultural Heritage Commission and the Long Beach City Council designated the McBride home, at 1461 Lemon Avenue, a historical city landmark; and


Dear Mr. Phil Hester,
