4 CITY OF LONG BEACH APPROVING, CONFIRMING AND
5 RATIFYING ORDINANCE NO. HD- 1969 OF THE BOARD OF
6 HARBOR COMMISSIONERS OF THE CITY OF LONG
7 BEACH, WHICH APPROVES AND AUTHORIZES THE
8 EXECUTION AND DELIVERY BY THE EXECUTIVE
9 DIRECTOR OF A GRANT DEED, AND MAKING A
10 DETERMINATION RELATING THERETO

12 WHEREAS, the Board of Harbor Commissioners of the City of Long
13 Beach has adopted Ordinance No. HD- 1969 on the 25th day of
14 September, 2006, a complete copy of which is attached hereto as Exhibit "A"
15 and incorporated herein by this reference; and

16 WHEREAS, Ordinance No. HD- 1969 of the Board of Harbor
17 Commissioners of the City of Long Beach approves and authorizes the execution and
18 delivery by the Executive Director of the Harbor Department of the City of Long Beach
19 and making a determination relating thereto; and

20 WHEREAS, this City Council concurs in the findings of, and wishes to
21 approve, confirm and ratify the actions taken by, the Board of Harbor Commissioners of
22 Ordinance No. HD- 1969; and

23 WHEREAS, the Director of Planning and Environmental Services for the
24 Harbor Department has determined a review of the applicability of the California
25 Environmental Quality Act (CEQA) to this Grant Deed that under the provisions of the
26 State Guidelines implementing CEQA, this ordinance is categorically exempt from the
27 provisions of CEQA.

2 Section 1. The City Council hereby finds and determines that the Grant
3 Deed is categorically exempt from the provisions of the California Environmental Quality
4 Act.

5 Sec. 2. The City Council of the City of Long Beach hereby concurs in the
6 findings of, and approves, confirms and ratifies the actions taken by, the Board of
7 Harbor Commissioners of the City of Long Beach in Ordinance No. HD-1969.

8 Sec. 3. The City Clerk shall certify to the passage of this ordinance by the
9 City Council and shall cause the same to be posted in three (3) conspicuous places in
10 the City of Long Beach. This ordinance shall take effect on the later of 31st day after its
11 approval by the Mayor of the City of Long Beach.



12 WHEREAS, the Board of Harbor Commissioners of the City of Long
13 Beach ("Board") desires to execute a Grant Deed with the City of Los Angeles, acting
14 by and through its Board of Harbor Commissioners, and Valero Refining Company-
15 California, a Delaware corporation (the "Grant Deed"); and

16 WHEREAS, guidelines adopted by the Secretary of the California
17 Resources Agency and by the Board, pursuant to Sections 21082-21084 of the
18 California Public Resources Code, provide that certain classes of projects listed therein
19 have been determined not to have a significant effect on the environment and are
20 categorically exempt from the provisions of the California Environmental Quality Act;
21 and

22 WHEREAS, the Director of Planning and Environmental Services of the
23 Long Beach Harbor Department has determined that, in accordance with the
24 guidelines, the Grant Deed is categorically exempt.

25 NOW, THEREFORE, the Board of Harbor Commissioners of the City of
26 Long Beach ordains as follows:


27 Section 1. The Board hereby finds and determines that the Grant Deed, a

2 provisions of the California Environmental Quality Act.


3 Sec. 2. The Executive Director of the Harbor Department of the City of
4 Long Beach is hereby authorized to execute the Grant Deed referred to in Section 1,
5 which is hereby approved.

6 Sec. 3. This ordinance shall be signed by the President or Vice President
7 of the Board and attested to by the Secretary. The Secretary shall certify to the
8 passage of this ordinance by the Board, shall cause the same to be posted in three (3)
9 conspicuous places in the City of Long Beach, and shall cause a certified copy of this
10 ordinance to be filed forthwith with the City Clerk. This ordinance shall take effect on
11 the later of 31st day after its final passage or approval by the City Council of this
12 ordinance.


