

1 FIRST AMENDMENT TO AGREEMENT NO. 33768

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33768 is made and
4 entered, in duplicate, as of December 17, 2015, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 January 6, 2015, by and between JASON ADDISON SMITH CONSULTING SERVICES,
7 INC. DBA JAS PACIFIC, a California corporation ("Consultant"), with a place of business
8 at 4295 Jurupa, Suite 203, Ontario, California 91761, and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed plan review and inspection services; and

12 WHEREAS, the parties entered Agreement No. 33768 whereby Consultant
13 agreed to provide these Services; and

14 WHEREAS, the parties desire to increase the Agreement amount by
15 \$200,000 for a total not to exceed amount of \$450,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions in this Agreement, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 33768 is hereby amended to read as
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, not to exceed Four Hundred
25 Fifty Thousand Dollars (\$450,000), at the rates or charges shown in Exhibit "B".

26 2. Except as expressly modified herein, all of the terms and conditions
27 contained in Agreement No. 33768 are ratified and confirmed and shall remain in full
28 force and effect.
