FIRST AMENDMENT TO AGREEMENT NO. 33768

THIS FIRST AMENDMENT TO AGREEMENT NO. 33768 is made and entered, in duplicate, as of December 17, 2015, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 6, 2015, by and between JASON ADDISON SMITH CONSULTING SERVICES, INC. DBA JAS PACIFIC, a California corporation ("Consultant"), with a place of business at 4295 Jurupa, Suite 203, Ontario, California 91761, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspection services; and

WHEREAS, the parties entered Agreement No. 33768 whereby Consultant agreed to provide these Services; and

WHEREAS, the parties desire to increase the Agreement amount by \$200,000 for a total not to exceed amount of \$450,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

1. Section 1.A. of Agreement No. 33768 is hereby amended to read as follows:

"1. SCOPE OF WORK OR SERVICES.

- A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Four Hundred Fifty Thousand Dollars (\$450,000), at the rates or charges shown in Exhibit "B"."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33768 are ratified and confirmed and shall remain in full force and effect.
