15 WHEREAS, funding for the Workforce Housing Reward Program ("Program")

16 has been made available pursuant to the Housing and Emergency Shelter Trust Fund Act

17 of 2002 (Proposition 46); and

18 WHEREAS, the California Department of Housing and Community

19 Development (the "HCD") issued a Notice of Funding Availability on March 19, 2004

20 ("NOFA") under the Program authorizing funding for capital asset projects on the terms and

21 conditions of the NOFA, the Program Guidelines and Application Package; and

22 WHEREAS, the City Council of the City of Long Beach, a political subdivision

23 of the State of California, wishes to apply for and submit an Application Package to receive

24 an allocation of up to \$1,000,000.00 through the Program; and

25 NOW, THEREFORE, the City Council of the City of Long Beach resolves as

26 follows:

27 Section 1. The City Council of the City of Long Beach shall submit to the

28 HCD an application to participate in the Program in response to the NOFA which will

1 request funding of up to \$1,000,000.00 for various capital asset projects to be identified
2 in the Standard Agreement.

3 Sec. 2. If the application for funding is approved, the City Council of the City
4 of Long Beach hereby agrees to use the Program funds for eligible capital asset projects
5 and activities in the manner presented in the NOFA Program Guidelines and the
6 Application Package.

7 Sec. 3. The City Council of the City of Long Beach authorizes the City
8 Manager to execute in the name of the City of Long Beach, the Application, the Standard
9 Agreement, and all other documents required by the HCD for participation in the Program,
10 any amendments thereto and any additional documents necessary to participate in the
11 Program, and all other instruments necessary or required by the HCD for participation in
12 the Program.

13 Sec. 4. This Resolution shall take effect immediately upon its adoption by
14 the City Council, and the City Clerk shall certify the vote adopting this Resolution.
