RESOLUTION NO. RES-21-0086

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH APPROVING THE APPLICATION FOR AND/OR EXECUTION OF GRANT FUNDS FROM THE OCEAN PROTECTION COUNCIL FROM PROPOSITION 1, PROPOSITION 68, PROPOSITION 84, ENVIRONMENTAL LICENSE PLATE FUNDS, ONCE THROUGH COOLING, OR GENERAL FUNDS

WHEREAS, the Legislature and Governor of the State of California have provided funds for the program shown above; and

WHEREAS, the California Natural Resources Agency has been delegated the responsibility for the administration of this grant program, establishing necessary procedures; and

WHEREAS, said procedures established by the California Natural Resources Agency require a resolution certifying the approval by the potential grantee's governing board either before submission of said application(s) to the State or prior to execution of the grant agreement; and

WHEREAS, the Applicant/Grantee, if selected, will enter into an agreement with the State of California to carry out the project.

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. Approves the filing of an application for the 51st Greenbelt Development Project to be funded by Ocean Protection Council.

Section 2. Certifies that Applicant or title holder will have sufficient funds to operate and maintain the project(s) consistent with the land tenure requirements; or

1 will secure the resources to do so;

2 Section 3. Certifies that the project will comply with any laws and
3 regulations including, but not limited to, the California Environmental Quality Act (CEQA),
4 legal requirements for building codes, health and safety codes, the California Labor
5 Code, disabled access laws, and, that prior to commencement of the project, all
6 applicable permits will have been obtained; and

7 Section 4. Certifies that the Applicant/Grantee will work towards the State
8 Planning Priorities intended to promote equity, strengthen the economy, protect the
9 environment, and promote public health and safety as included in Government Code
10 Section 65041.1; and,

11 Section 5. Appoints the City Manager, or designee, as agent to conduct
12 all negotiations, execute and submit all documents including, but not limited to
13 applications, agreements, payment requests and so on, which may be necessary for the
14 completion of the aforementioned project(s).

15 Section 6. This resolution shall take effect immediately upon its adoption
16 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
