AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE USE DISTRICT MAP OF THE CITY OF LONG BEACH AS SAID MAP HAS BEEN ESTABLISHED AND AMENDED BY AMENDING PORTIONS OF PART 11 OF SAID MAP FROM THREE FAMILY RESIDENTIAL DISTRICT (R-3-S) TO COMMUNITY R-4-N DISTRICT (CCN) FOR PROPERTY LOCATED AT 4200 E. ANAHEIM STREET, IN THE CITY OF LONG BEACH (RZ-0505-19)

The City Council of the City of Long Beach ordains as follows:

Section 1. Environmental documentation having been prepared, certified, received and considered as required by law, and the City Council hereby finding that the proposed change will not adversely affect the character, livability or appropriate development of the surrounding area and that the proposed change is consistent with the goals, objectives and provisions of the General Plan, the official Use District Map of the City of Long Beach, as established and amended, is further amended by amending portions of Part 11 of said Map to rezone the subject property from Three Family Residential (R-3-S) to Community R-4-N District (CCN). That portion of Part 11 of said map that is amended by this ordinance is depicted on Exhibit "A" which are attached hereto and by this reference made a part of this ordinance and the official Use District Map.
