3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH APPROVING THE APPOINTMENT  
5 AND TERMS OF COMPENSATION OF THE CITY CLERK

7 WHEREAS, the City Clerk for the City of Long Beach was appointed as  
8 Interim City Clerk for a term effective from May 1, 2015 to approximately August 31,  
9 2015; and

10 WHEREAS, on July 7, 2015, following a recruitment for a new City Clerk,  
11 the City Council met in closed session pursuant to California Government Code Section  
12 54957, where several candidates were interviewed by the City Council; and

13 WHEREAS, on July 21, 2015, following a closed session held pursuant to  
14 California Government Code Section 54957, the City Council voted unanimously to select  
15 Maria de la Luz Garcia as the City Clerk; and

16 WHEREAS, on July 21, 2015, pursuant to California Government Code  
17 Section 54957.6, following the selection of Maria de la Luz Garcia, the City Council  
18 provided direction to labor negotiators regarding the terms of compensation for the City  
19 Clerk;

20 WHEREAS, at the direction of City Council, the City has reached an  
21 agreement with Maria de la Luz Garcia regarding compensation for the position of City  
22 Clerk.

23 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
24 follows:

25 Section 1. The City Council approves the appointment of Maria de la Luz  
26 Garcia as the City Clerk for the City of Long Beach.

27 Section 2. The City Council approves the terms of compensation for the
