

1 SECOND AMENDMENT TO CONTRACT NO. 34732

3 THIS SECOND AMENDMENT TO CONTRACT NO. 34732 is entered into,
4 in duplicate, effective as of September 3, 2020, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 July 18, 2017, by and between EDU CONSULTING LLC, a California limited liability
7 company ("Contractor"), with offices located at 18916 Silverbit Lane, Huntington Beach,
8 California 92648, and the CITY OF LONG BEACH, a municipal corporation ("City") and
9 administering entity for Pacific Gateway Workforce Investment Network.

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 34732 whereby Contractor agreed to provide various workforce development services to
12 Pacific Gateway and its Board; and

13 WHEREAS, the Parties entered into a Second Amendment to the Agreement
14 to add \$175,000; and

15 WHEREAS, the Parties desire to utilize the remaining two options to extend
16 the term;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions herein contained, the Parties agree as follows:

19 1. Section 2.A of Contract No. 34732 is hereby amended to read as
20 follows:

21 "A. The term of this Contract ("Term") shall be deemed to have
22 commenced as of July 1, 2017, and unless sooner terminated pursuant to the provisions
23 hereof, shall terminate on June 30, 2021. Either of the parties hereto shall have the right
24 to terminate this Contract in its entirety at any time during the Term for any or no reason
25 whatsoever by giving fifteen (15) days prior written notice of termination to the other party.
26 City shall have the additional right to cancel any part of this Contract at any time during the
27 Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to
28 the Contractor."
