Due to continued rising feedstock costs and strong global demand, polypropylene and polyethylene resin producers continue to announce price increases for their products. Additionally, the unusually harsh winter weather in the Gulf Region has negatively impacted resin producer operations and transportation systems in and out of the area. As a result, this has created increasingly tight supply positions for all major resin producers.

Current market conditions for polypropylene resin have led resin manufacturers to implement a third increase (effective March 1<sup>st</sup>) since December of 2020. They have also announced a fourth increase scheduled to take effect on April 1, 2021. Polyethylene resin producers have also implemented a third increase (effective March 1<sup>st</sup>) since December of 2020 and have indicated another increase for April 1, 2021 as well. The impact of the resin increases already in effect, or announced, represents nearly a 50% increase in resin per pound cost. While Medegen has absorbed these resin cost increases over the past several months, we have reached the point where absorbing the entirety of the resin increases is unsustainable.

These significant increases in raw material costs and other rising costs, such as corrugated packaging, force us to implement a sales price increase on our products. Effective May 1, 2021, Medegen Medical Products, and Minigrip Commercial LLC, will implement up to a 15% increase on all impacted product prices for orders on or after this date. A copy of the price list is here attached. We reserve the right to limit order quantities, and we will only accept orders calling for delivery within our current lead times.


