

1 FIRST AMENDMENT TO CONTRACT NO. 29274

3 THIS FIRST AMENDMENT TO CONTRACT NO. 29274 is made and  
4 entered, in duplicate, as of April 1, 2006 for reference purposes only, pursuant to a minute  
5 order adopted by the City Council of the City of Long Beach at its meeting on April 12,  
6 2005, by and between LENNY ARKINSTALL SR., dba THE LOS CERRITOS WETLANDS  
7 STEWARDSHIP, INC., a California corporation, with its principal office at 6289 E. Pacific  
8 Coast Highway, Slip F39, Long Beach, California 90803, "Contractor" and the CITY OF  
9 LONG BEACH, a municipal corporation, hereinafter referred to as the "City."

10 WHEREAS, the parties entered Contract No. 29274 as of April 1, 2005 for  
11 Contractor to provide professional services for the maintenance and management of  
12 environmentally sensitive areas as identified in Contract No. 29274; and

13 WHEREAS, Contract No. 29274 provided for a one-year term, with two one-  
14 year options for renewal at the sole discretion of the City; and

15 WHEREAS, the City desires to extend the term of the Contract;

16 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
17 Contract No. 29274, the parties agree as follows:

18 1. Section 2 of Contract No. 29274 is hereby amended in its entirety to read  
19 as follows:

20 "2. The term of this Agreement shall commence on April 1, 2005 and shall  
21 end on March 31, 2007, provided, however, that City shall have the right to terminate this  
22 Agreement without penalty and without cause by giving thirty (30) days prior notice to  
23 Contractor. The City, in its sole discretion, may extend this Agreement for one (1)  
24 additional year at an annual amount not to exceed One Hundred Twenty-Five Thousand  
25 Dollars (\$125,000)."

26 2. Except as expressly amended herein, all of the terms and conditions of  
27 Contract No. 29274 are ratified and confirmed and shall remain in full force and effect.
