3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT WITH MCNEILUS
6 FINANCIAL, INC. DBA MCNEILUS TRUCK AND
7 MANUFACTURING, WITHOUT ADVERTISING FOR BIDS,
8 FOR THE PURCHASE OF MCNEILUS REFUSE TRUCK
9 PARTS FOR A PERIOD OF TWO YEARS WITH THE OPTION
10 TO RENEW FOR THREE ADDITIONAL ONE-YEAR PERIODS
11 FOR AN ANNUAL AMOUNT OF \$100,000

13 WHEREAS, there are twenty-one (21) McNeilus refuse trucks used daily by
14 the Department of Public Works; and

15 WHEREAS, refuse trucks are complex vehicles, with extensive hydraulic
16 and mechanical systems, which require constant maintenance and service; and

17 WHEREAS, to maintain the McNeilus refuse trucks, parts from the original
18 equipment manufacturer are needed to ensure their continued reliable operation; and

19 WHEREAS, McNeilus Financial, Inc. dba McNeilus Truck & Manufacturing
20 is the sole provider of McNeilus refuse truck body parts for McNeilus trucks in the State of
21 California; and

22 WHEREAS, no useful purpose would be served by advertising for bids and
23 to do so would constitute an idle and useless act and an unnecessary expenditure of
24 public funds;

25 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
26 follows:

27 Section 1. The City Manager is hereby authorized to enter into a

1 contract, without advertising for bids, with McNeilus Financial, Inc. dba McNeilus Truck &
2 Manufacturing for the purchase of McNeilus refuse truck parts as may be required by the
3 City for a period of two (2) years in an annual amount of One Hundred Thousand Dollars
4 (\$100,000), plus a fifteen percent (15%) contingency of Fifteen Thousand Dollars
5 (\$15,000), for a total not to exceed amount of One Hundred Fifteen Thousand Dollars
6 (\$115,000). The parties may, by mutual agreement, extend the term for three (3)
7 additional one-year periods, at the discretion of the City Manager.

8 Section 2. This resolution shall take effect immediately upon its adoption
9 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
