

# Background

On September 19, 2006, the City Council approved the PSAC recommendation and requested the City Attorney and Health Department draft a comprehensive and cost effective Tobacco Retail Permit program and any needed ordinances.

## The Solution

Strong Tobacco Retail Permit Programs reduce illegal sales to children and youth.

More than 70 cities and counties in California are reducing illegal sales of tobacco to youth with Tobacco Permit Programs.

### These Tobacco Permit Programs are Reducing Illegal Sales Rates

City	Youth Sales Rate Prior to Tobacco Retail Permit	Youth Sales Rate After Tobacco Retail Permit
Pasadena	20%	5%
Riverside	65%	0%
Berkeley	38%	19%
Contra Costa	37%	7%

In one year, the City of Los Angeles' rate of tobacco sales to minors was reduced from 31.9% to 22%.

# A Strong Tobacco Retail Permit Program will:


- Cover all costs of enforcement and operations to the City of Long Beach,
- Require tobacco retailers to pay an estimated annual permit fee of \$395 that averages only \$1.08 per day for retailers,
- Require retailers to comply with all tobacco laws that relate to youth,
- Recognize responsible tobacco retailers that do NOT sell to minors.

#### A Strong Tobacco Retail Permit Program will reduce illegal tobacco sales to minors as it has done in other cities



Environmental Health Enforcement: Tobacco Permit Violations

- Improper display of City or State tobacco permit or license
- Improper placement of tobacco products (i.e. in front of the counter, etc.)
- Sale of single cigarettes
- Sale of bidis (flavored cigarettes from India)
- Lack of S.T.A.K.E. Act signage
- Any other youth tobacco related laws

# TRP Program Operations and Enforcement

- Public notice of the new law in English, Spanish and Khmer.
- Develop a TRP Policies and Procedures Manual with City departments implementing the new permit.
- Mail instructions on how to apply for the permit to all businesses with Food Permits which are most likely to sell tobacco products, and
- Include TRP Program phone number to call with questions.

## **TRP** Operations and **Enforcement** Continued

- Create database of known tobacco retailers and set up accounts.



- Set a target date for the initial billing.
- Continue Police Tobacco Decoy operations/stings for illegal sales to minors violations.
- Schedule in store visits for Environmental Health Inspector and TRP Program Coordinator to every retailer at least once a year to check for permit violations.
