SECOND AMENDMENT TO AGREEMENT NO. 35554

THIS SECOND AMENDMENT TO AGREEMENT NO. 35554 is made and entered, in duplicate, as of December 6, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 9, 2020, by and between SWS2, INC. DBA THE RYTE PROFESSIONALS, a California corporation ("Consultant"), whose address is 4699 Montefino Drive, Cypress, California 90630, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35554 (the "Agreement") whereby Consultant agreed to provide as-needed professional and technical services for system analysis, development, implementation, project management, and technical support for information technology projects and systems; and

WHEREAS, the Parties entered into a First Amendment to extend the term one (1) additional one-year period;

WHEREAS, the Parties currently desire to increase the annual contract amount to Two Million Five Hundred Thousand (\$2,500,000);

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an amount not to exceed Two Million Five Hundred Dollars (\$2,500,000) annually, at the rates or charges shown in Exhibit "B"."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35554 are ratified and confirmed and shall remain in full force and effect.
