FIRST AMENDMENT TO AGREEMENT NO. 34389

34389

THIS FIRST AMENDMENT TO AGREEMENT NO. 34389 is made and entered, in duplicate, as of June 19, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 5, 2016, by and between SIMPLUS MANAGEMENT CORPORATION, a California corporation ("Consultant"), with a place of business at ~~4431 Corporate Center Drive, Suite 111, Los Alamitos, California 90720~~ 11095 Knott Ave., Ste. L Cypress, CA 90630, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34389 (the "Agreement") whereby Consultant agreed to provide as-needed public works construction management and inspection services; and

WHEREAS, the Parties desire to add \$1,000,000 for a total not to exceed amount of \$2,000,000 and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:
"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Million Dollars (\$2,000,000), at the rates or charges shown in Exhibit "B".

2. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on August 31, 2016, and shall terminate at 11:59 p.m. on August 31, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for one (1) additional one-year period, at the discretion of the City Manager."
