ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH AMENDING THE LONG BEACH  
MUNICIPAL CODE BY AMENDING SECTION 10.32.110  
RELATING TO PREFERENTIAL PARKING DISTRICT "R"

WHEREAS, residents on Snowden Avenue between Marita Street and Los Santos Drive have requested inclusion in Preferential Parking District "R" to seek on-street parking relief due to overflow parking generated by California State University Long Beach students; and

WHEREAS, the residents have requested that a two-hour parking restriction, from 9:00 a.m. to 9:00 p.m., Monday through Friday, except Saturdays, Sundays and holidays, be established within the proposed preferential parking district expansion; and

WHEREAS, a parking study conducted by staff during the peak period of activity on Snowden Avenue revealed that seventy-eight percent (78%) of existing on-street parking spaces within the block area were occupied at the time of the survey and that fifty-two percent (52%) of the vehicles were not registered to residents of the neighborhood; and

WHEREAS, a petition formally requesting the expansion of Preferential Parking District "R" and a two-hour parking restriction from 9:00 a.m. to 9:00 p.m., Monday through Friday, except Saturdays, Sundays and holidays, was circulated among the residents; and

WHEREAS, a review of the petition by staff revealed that one hundred percent (100%) of the residents are in favor of implementing a preferential parking district and the proposed parking restrictions; and

WHEREAS, the City Traffic Engineer has reviewed the results of the

1 parking study, the resident petition and the feedback responses from the mailing, and he  
2 has determined that conditions meet minimum municipal code criteria as outlined in  
3 LBMC 10.32.020 for inclusion in the preferential parking district;

4 NOW, THEREFORE, the City Council of the City of Long Beach does  
5 hereby ordain as follows:

6  
7 Section 1. District "R" of Section 10.32.110 of the Long Beach Municipal  
8 Code is hereby amended to read as follows:

9 District R: Both sides of McNab Avenue between Atherton Street  
10 service road and Marita Street; both sides of Conquista Avenue between  
11 Atherton Street service road and Dayman Street; both sides of Fanwood  
12 Avenue between Atherton Street service road and Los Santos Drive; both  
13 sides of Dayman Street between Snowden Avenue and Conquista Avenue;  
14 both sides of Dayman Street between Snowden Avenue and Conquista  
15 Avenue; both sides of the Palo Verde Avenue service road between the  
16 Atherton Street service road and Marita Street; both sides of Tevis Avenue  
17 between the Atherton Street service road and Dayman Street; both sides of  
18 Snowden Avenue between the Atherton Street service road and Dayman  
19 Street; both sides of Carfax Avenue between the Atherton Street service road  
20 and Marita Street; both sides of Marita Street between Fanwood Avenue and  
21 the Palo Verde Avenue service road; both sides of Faust Avenue between  
22 Marita Street and end of the cul-de-sac; both sides of Senasac Avenue  
23 between Marita Street and end of the cul-de-sac; both sides of College Circle  
24 between the Atherton Street service road east and the Atherton Street service  
25 road west; both sides of College Place between the Atherton Street service  
26 road and College Circle; both sides of Fairbrook Street between Snowden  
27 Avenue and Conquista Avenue; both sides of Conquista Avenue between  
28 Marita Street and Fairbrook Street; both sides of the Atherton Street service

1 road between Fanwood Avenue and the Palo Verde Avenue service road;  
2 both sides of Snowden Avenue between Marita Street and Los Santos Drive.

3  
4 Section 2. The City Clerk shall certify to the passage of this ordinance by  
5 the City Council and cause it to be posted in three (3) conspicuous places in the City of  
6 Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the  
7 Mayor.
