THIRD AMENDMENT TO CONTRACT NO. 35109

**35109**

THIS THIRD AMENDMENT TO CONTRACT NO. 35109 is made and entered into as of September 13, 2022, for reference purposes only, pursuant to Resolution No. RES-18-0122, adopted by the City Council of the City of Long Beach at its meeting on August 14, 2018, by and between TROY SHEET METAL WORKS, INC., a California corporation ("Contractor"), with a place of business at 1024 S. Vail Avenue, Montebello, CA 90640, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City desired to purchase command equipment boxes for police vehicles ("Command Equipment Boxes"); and

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 35109 (the "Contract") whereby Contractor agreed to furnish the Command Equipment Boxes; and

WHEREAS, the Parties entered a First Amendment to extend the term of the Contract;

WHEREAS, the Parties entered a Second Amendment to extend the term of the Contract and increase the contract amount;

WHEREAS, the Parties desire to amend the contract to extend the term for an additional one-year period and amend the yearly contract amount to One Hundred Sixty-Five Thousand Dollars (\$165,000) for the August 15, 2022 to August 14, 2023 term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2. of the Contract is hereby amended to read as follows:
- "2. City shall pay Contractor in due course of payments, following receipt of an invoice from Contractor and upon acceptance from City, for command equipment boxes for police vehicles, the prices shown in Exhibit "A" attached hereto, a sum not to exceed One Hundred Sixty-Five Thousand Dollars (\$165,000) for the August 15, 2022 to August 14, 2023 term, for a total not to exceed Contract amount of Eight

1 Hundred Eighty Thousand dollars (\$880,000.00).

2 2. Section 3 of the Contract is hereby amended to read as follows:

3 "3. The term of this Contract shall commence on August 15, 2018, and  
4 shall terminate at midnight on August 14, 2023, unless sooner terminated as provided  
5 herein. The City may terminate this Contract by giving thirty (30) days prior notice of  
6 termination to Contractor."

7 3. Except as expressly modified herein, all of the terms and conditions  
8 contained in Contract No. 35109 are ratified and confirmed and shall remain in full force  
9 and effect.

10 IN WITNESS WHEREOF, the Parties have caused this document to be  
11 duly executed with all formalities required by law as of the date first stated above.
