

ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY ADDING DISTRICT AA TO SECTION 10.32.110 CREATING A NEW PREFERENTIAL PARKING DISTRICT

WHEREAS, residents of Parkcrest Street, adjacent to the south side of Heartwell Park, east of Bellflower Boulevard and south of Carson Street, have requested the establishment of a new Preferential Parking District to seek on-street parking relief due to overflow parking generated by the public using the Heartwell Park sports facilities; and

WHEREAS, a parking study was conducted during a peak period of activity at Heartwell Park and revealed that all the existing on-street parking spaces within a five-block area were occupied at the time of the study; and

WHEREAS, eighty-six percent (86%) of the vehicles parked were not registered to residents of the neighborhood; and

WHEREAS, a petition formally requesting the establishment of a Preferential Parking District was circulated among the residents of a five block area; and

WHEREAS, the City Traffic Engineer has reviewed the results of the parking study and the resident petition and he has determined that conditions on the streets adjacent to Heartwell Park meet minimum municipal code criteria as outlined in LBMC 10.32.020 for the consideration of a Preferential Parking District; and

NOW, THEREFORE, the City Council of the City of Long Beach does hereby ordain as follows:

Section 1. District "AA" is added to Section 10.32.110 of the Long Beach

1 Municipal Code to read as follows:

2 District AA: South side of Parkcrest Street between Marber Avenue
3 and Albury Avenue; both sides of Marber Avenue between Parkcrest Street
4 and Hanbury Street; both sides of San Anseline Avenue between Parkcrest
5 Street and approximately four hundred feet (400') south of Parkcrest Street;
6 and both sides of Albury Avenue between Parkcrest Street and Hanbury
7 Street.

9 Section 2. The City Clerk shall certify to the passage of this ordinance by
10 the City Council and cause it to be posted in three (3) conspicuous places in the City of
11 Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the
12 Mayor.
