## SECOND AMENDMENT TO AGREEMENT NO. 29238

2 THIS SECOND AMENDMENT TO AGREEMENT NO. 29238 ("Amendment") is  
3 made and entered, in duplicate, as of December 13, 2006, for reference purposes only,  
4 pursuant to a minute order adopted by the City Council of the City of Long Beach at its  
5 meeting on December 5, 2006, by and between COMMUNITY HOSPITAL OF LONG  
6 BEACH, a public benefit corporation ("Contractor"), and the CITY OF LONG BEACH  
7 ("City").

8 WHEREAS, the parties entered Agreement No. 29238 whereby Contractor agreed  
9 to provide emergency services with respect to persons booked by the City's Police  
10 Department and victims of certain crimes; and

11 WHEREAS, the parties entered into the First Amendment to Agreement No. 29238,  
12 dated as of April 20, 2006, which extended the term of the Agreement to terminate at  
13 midnight on April 30, 2007, and which granted the City an option to extend the term of this  
14 Agreement for one (1) additional year, upon authorization by the City's City Council.

15 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
16 Agreement No. 29238, the First Amendment, and herein the parties agree as follows:

17 1. The second sentence of Section 2 of the Agreement No. 29238, is hereby  
18 amended in its entirety to read as follows:

19 "2. City shall have the option to extend the term of this Agreement for one (1)  
20 additional year, at the discretion of the City Manager.

21 2. Section 4, line 24 of Agreement No. 29238 is hereby amended in its entirety to  
22 read as follows:

23 The total compensation to be paid under this Agreement shall not exceed Three  
24 Hundred and Fifty Thousand Dollars (\$350,000.00) for the period commencing at midnight  
25 on May 1, 2006 through midnight on April 30, 2007. Should the city exercise its option to  
26 renew the Agreement for one (1) additional year, the total compensation to be paid for the  
27 period commencing at midnight on ~~May 1, 2007~~ through midnight on April 20, 2008 shall  
28 not exceed Four Hundred Thousand Dollars (\$400,000.00).

1           3. Except as expressly amended herein, all terms and conditions in Agreement No.  
2 29238 are ratified and confirmed and shall remain in full force and effect.

3           IN WITNESS WHEREOF, the parties have caused this Amendment to be duly  
4 executed with all formalities required by law as of the date first stated above.


