FIRST AMENDMENT TO AGREEMENT NO. 29299

THIS FIRST AMENDMENT TO AGREEMENT NO. 29299 is made and entered, in duplicate, as of November 1, 2005 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 3, 2005, by and among LONG BEACH COMMUNITY SERVICES DEVELOPMENT CORPORATION, INC. ("LBCSDC"), the CITY OF LONG BEACH ("City"), and the LONG BEACH UNIFIED SCHOOL DISTRICT OF LOS ANGELES COUNTY ("District").

WHEREAS, Agreement No. 29299 was entered to define the collaborative efforts of the parties through a Role of Men Academy; and

WHEREAS, the Section 5 of the Agreement stated that the parties shall execute an amendment to identify the budget for each year of the Agreement and now desire to do so;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and herein, the parties agree as follows:

- 1. In accordance with Section 5 of Agreement No. 29299, the parties agree to the following budgeted amounts: For the period from October 1, 2005 through September 30, 2006, LBCSDC shall pay to the City on October 1, 2005, on January 1, 2006, on April 1, 2006 and on July 1, 2006 the sum of \$28,787.50 on each date. For the same period, LBCSDC shall pay to the District on October 1, 2005 the sum of \$12,600. And, LBCSDC shall retain the sum of \$22,250.
- Except as expressly amended in this First Amendment, all terms and conditions in Agreement No. 29299 are ratified and confirmed and shall remain in full force and effect.
