3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT WITH HAAKER
6 EQUIPMENT COMPANY, WITHOUT ADVERTISING FOR
7 BIDS, FOR THE PURCHASE OF A MADVAC COMPACT
8 SWEEPER IN AN AMOUNT NOT TO EXCEED \$111,896

10 WHEREAS, the Environmental Services Bureau is currently utilizing one
11 Madvac compact sweeper and has documented the need for additional compact
12 sweepers to adequately and regularly clean the additional miles of protected bike lanes
13 the City has added; and

14 WHEREAS, the purchase of this compact sweeper is the most cost efficient
15 way to enable regular scheduled service to be provided; and

16 WHEREAS, Haaker Equipment Company is the exclusive distributor of
17 Exprolink Madvac Sweepers and Vacuums in the territories of California, Nevada and
18 Arizona; and

19 WHEREAS, as a result, no useful purpose would be served by advertising
20 for bids and to do so would constitute an idle and useless act and an unnecessary
21 expenditure of public funds;

22 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
23 follows:

24 Section 1. The City Manager is hereby authorized to enter a contract
25 with Haaker Equipment Company for the purchase of a Madvac compact sweeper in an
26 annual sum not to exceed One Hundred Eleven Thousand Eight Hundred Ninety Six
27 Dollars (\$111,896), including taxes and fees.

28 Section 2. This resolution shall take effect immediately upon its adoption
