

1 FIRST AMENDMENT TO AGREEMENT NO. 35545

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35545 is made and
4 entered, in duplicate, as of March 15, 2021, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on March
6 2, 2021, by and between GREAT SCOTT TREE SERVICE, INC., a California corporation
7 ("Contractor"), with a place of business at 10761 Court Ave., Stanton, CA 90680, and the
8 CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.
10 35545 (the "Agreement") whereby Contractor agreed to provide as-needed tree trimming,
11 removal, planting, inventory, and stump grinding services for parks, beach areas, marinas,
12 and open space areas for the Parks, Recreation and Marine Department; and

13 WHEREAS, the Department of Public Works requires tree trimming services
14 for the Colorado Lagoon Open Channel Phase 2A Project; and

15 WHEREAS, the Public Works Project needed to be completed before
16 January 1, 2021, which is outside of bird nesting season; and

17 WHEREAS, the Parties desire to add \$60,000 to the Agreement for the Public
18 Works Project for a total not to exceed amount of \$1,030,025 for the term ending March
19 31, 2021;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
21 conditions herein contained, the Parties agree as follows:

22 1. Section 1.A. of the Agreement is hereby amended to read as follows:

23 "A. Contractor shall furnish specialized services more particularly
24 described in Exhibit "A", attached to the Agreement and incorporated by this
25 reference, which was submitted in response to City's RFP, in accordance with the
26 standards of the profession, and City shall pay for these services in the manner
27 described below, in an annual amount not to exceed Eight Hundred Forty Three
28 Thousand Five-Hundred Dollars (\$843,500), with a fifteen percent (15%)

1 contingency in the amount of One Hundred Twenty Six Thousand Five Hundred
2 Twenty Five Dollars (\$126,525), for a total annual contract amount not to exceed
3 Nine Hundred Seventy Thousand Twenty Five Dollars (\$970,025), for a period of
4 two years, with the option to renew for three additional one-year periods, at the rates
5 or charges shown in Exhibit "B". An additional Sixty Thousand Dollars (\$60,000) is
6 added to the term ending March 31, 2021 for a total not to exceed annual amount
7 of One Million Thirty Thousand Twenty-Five Dollars (\$1,030,025)."

8 2. Except as expressly modified herein, all of the terms and conditions
9 contained in Agreement No. 35545 are ratified and confirmed and shall remain in full force
10 and effect.
