## RESOLUTION NO. RES-23-0153

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH RECOGNIZING EVERY 7TH DAY OF OCTOBER OF EVERY YEAR AS AGEISM AWARENESS DAY, A DAY OF CELEBRATION IN THE CITY OF LONG BEACH

WHEREAS, "ageism" refers to stereotypes, prejudice, and discrimination directed toward others or oneself based on age; and

WHEREAS, preventing ageism in education, employment, housing, and healthcare will benefit all and ensure that older adults are respected and portrayed as capable, competent, effective, and valued in all areas of society; and

WHEREAS, the City of Long Beach ("City") is the second largest city in the County of Los Angeles with over a quarter of its adult population being over fifty (50) years of age; and

WHEREAS, the City has committed itself to better address the needs of older adults through a variety of structures and services including the Strategic Plan for Older Adults, the Long Beach Age-Friendly Initiative, the Healthy Aging Center, and a Senior Sage Home; and

WHEREAS, recognizing Ageism Awareness Day in the City is an important opportunity to draw attention to the existence and impact of ageism in our society, and will allow the City to reframe the idea of aging in its communities;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City Council hereby recognizes October 7th of every year in the City of Long Beach as Ageism Awareness Day to celebrate the City's adult population of those over fifty (50) years of age, bring more awareness to ageism and its impact in our
