As a long term resident and participant in several initiatives concerned with homelessness, I strongly support this recommendation, and hope that the City Council will prioritze it for timely action. The proposal will take advantage of upcoming funding to meet the critical need of temporary non-congregant shelter and services for 500 at-risk senior and disabled homeless residents of our community by acquiring available empty motels. Long Beach has a large and needy population experiencing homelessness -over 1700 in the recently completed count-, a number expanding with the current pandemic and economic crisis. Their numbers create a public health crisis for the community as well as the individuals affected, and the provision of 500 beds would make a substantial reduction in the need for housing. Funding available for Immediate use could provide temporary shelter and and immediate service, and could later be remodelled to offer bridge housing and programs as part of a city plan to respond to the recommendations of the Mayor's Everyone Home Task force for long term solutions to homelessness. Since funding sources have been identified, and motel acquisition RFP begins on July 16, we request that the council set a report back date ordinance in two weeks, for an ordinance that would outline a plan for developing long term bridge housing. and services.
