1 FIFTH AMENDMENT TO AGREEMENT NO. 34167

3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 34167 is made and  
4 entered, in duplicate, as of April 23, 2020, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April  
6 21, 2020, by and between AMERICAN CORRECTIONAL SOLUTIONS, INC., a California  
7 corporation ("Contractor"), with a place of business at 741 E. Ball Road, Ste. #101,  
8 Anaheim, CA 92805, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be  
10 performed in connection with Jail Inmate Medical Services; and

11 WHEREAS, the parties entered Agreement No. 34167 ("Contract") whereby  
12 Contractor agreed to provide these services; and

13 WHEREAS, the parties desire to extend the term of the Contract, update  
14 the cost schedule and add \$400,000 for the term extension;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
16 conditions herein contained, the parties agree as follows:

17 1. Section 1.A. of Agreement No. 34167 is hereby amended to read as  
18 follows:

19 "1. SCOPE OF WORK OR SERVICES.

20 A. Contractor shall furnish specialized services more  
21 particularly described in Exhibit "A-2", attached to this Agreement and  
22 incorporated by this reference, in accordance with the standards of the profession,  
23 and City shall pay for these services in the manner described below, not to exceed  
24 Seven Hundred Sixty Thousand Dollars (\$760,000.00), for the period ending on  
25 September 1, 2019, and a revised total amount not to exceed Nine Hundred  
26 Thousand Dollars (\$900,000.00), for the period beginning on September 2, 2019  
27 through November 30, 2020, at the rates or charges shown in Exhibit "A-2".

1                   2.     Section 2. of Agreement No. 34167 is hereby amended to read as  
2 follows:

3                   “2.     TERM.   The term of this Agreement shall commence at  
4                   midnight on September 1, 2015, and shall terminate at 11:59 p.m. on November  
5                   30, 2020, unless sooner terminated as provided in this Agreement, or unless the  
6                   services or the Project is completed sooner.”

7                   3.     The Rates or Charges in Exhibit “A” to the Agreement are hereby  
8                   amended to include revised hourly rates, overtime, and holiday pay in accordance with  
9                   the Cost Schedule, attached hereto and incorporated by this reference as Exhibit “A”.

10                  4.     Except as expressly modified herein, all the terms and conditions  
11                  contained in Agreement No. 34167 are ratified and confirmed and shall remain in full  
12                  force and effect.
