

1 FIRST AMENDMENT TO AGREEMENT NO. 33840

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33840 is made and  
4 entered, in duplicate, as of March 21, 2017, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April  
6 7, 2015, by and between LG2WB ENGINEERS, INC. DBA LINSKOTT, LAW &  
7 GREENSPAN ENGINEERS, a California corporation ("Consultant"), with a place of  
8 business at 2 Executive Circle, Suite 250, Irvine, California 92614, and the CITY OF  
9 LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be  
11 performed in connection with as-needed traffic engineering, transportation planning and  
12 related technical and professional services; and

13 WHEREAS, the City and Consultant (the "Parties") entered Agreement No.  
14 33840 (the "Agreement") whereby Consultant agreed to provide these services; and

15 WHEREAS, the Parties desire to decrease the Agreement amount by  
16 \$100,000 for a total not to exceed amount of \$300,000;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
18 conditions herein contained, the parties agree as follows:

19 1. Section 1.A. of the Agreement is hereby amended to read as follows:

20 "A. Consultant shall furnish specialized services more particularly  
21 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in  
22 accordance with the standards of the profession, and City shall pay for these services in  
23 the manner described below, not to exceed Three Hundred Thousand Dollars  
24 (\$300,000), at the rates or charges shown in Exhibit "B"."

25 2. Except as expressly modified herein, all of the terms and conditions  
26 contained in Agreement No. 33840 are ratified and confirmed and shall remain in full  
27 force and effect.




