SECOND AMENDMENT TO LICENSE AGREEMENT NO. 33468

THIS SECOND AMENDMENT TO LICENSE AGREEMENT NO. 33468 is made and entered, in duplicate as of January 16, 2019 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on January 21, 2014, by and between LEE OSTENDORF, an individual (“Licensee”), and the CITY OF LONG BEACH, a municipal corporation (“City”).

WHEREAS, City and Licensee entered into License Agreement No. 33468 (the “Agreement”) wherein City granted Licensee a non-exclusive revocable license for the sole purpose of conducting a farmers’ market at Bixby Park, located at 130 Cherry Avenue, every Tuesday evening from 3:00 p.m. to 7:00 p.m.; and

WHEREAS, City and Licensee entered into a First Amendment to the Agreement to add a Saturday farmers’ market at Bixby Park, extend the term, and amend the license fee; and

WHEREAS, City and Licensee desire to extend the term one (1) additional two-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions herein contained, the parties agree as follows:

1. Section 3 of the Agreement is amended in its entirety to read as follows:

“3. TERM. The term of this License Agreement shall commence on January 1, 2014 and shall terminate on December 31, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner.”

2. Except as expressly amended herein, all terms and conditions in Agreement No. 33468 are ratified and confirmed and shall remain in full force and effect.
