THIS THIRD AMENDMENT TO AGREEMENT NO. 33453 is made and entered, in duplicate, as of November 2, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 3, 2015, by and between BUNNELL ENTERPRISES, INC. DBA TOTAL NETWORK SOLUTIONS, a California corporation, located at 5150 E. Pacific Coast Highway, Suite 530, Long Beach, CA 90804 ("Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed on an as-needed basis in connection with professional and technical services for information technology projects and systems; and

WHEREAS, the City and Contractor entered into Agreement No. 33453 (the "Agreement") whereby Contractor agreed to provide these services; and

WHEREAS, City and Contractor entered into a First Amendment to the Agreement to increase the total not to exceed amount to \$150,000; and

WHEREAS, City and Contractor entered into a Second Amendment to the Agreement to extend the term and increase the total not to exceed amount to \$350,000; and

WHEREAS, City and Contractor again desire to increase the total not to exceed amount;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Amendment, the parties agree as follows:

- 1. Section 1.A of the Agreement is hereby amended to read as follows:
 - "A. Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, a total not to exceed contract

1 amount of Five Hundred Thousand Dollars (\$500,000), at the rates or charges
2 shown in Exhibit "A".

3 2. Except as expressly modified herein, all of the terms and conditions
4 contained in Agreement No. 33453 are ratified and confirmed and shall remain in full force
5 and effect.
