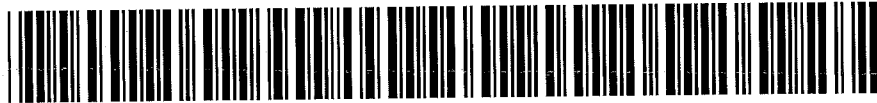

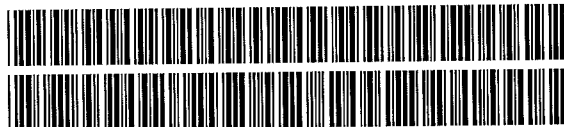

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH SETTING APART AND DEDICATING FOR PUBLIC STREET PURPOSES PORTIONS OF CITY-OWNED PROPERTY LOCATED AT AND/OR NEAR THE INTERSECTION OF WALNUT AVENUE, 20TH STREET AND ALAMITOS AVENUE IN THE CITY OF LONG BEACH, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA

WHEREAS, the City of Long Beach is in the process of reconfiguring the intersection where 20th Street meets Walnut Avenue and Alamitos Avenue, in order to improve the safety of students that attend nearby schools; and

WHEREAS, the street reconfiguration will require relocation of Southern California Edison poles, and installation of overhead electrical supply and communications systems, as well as the dedication of approximately 1,673 square feet of City property at the northeast corner of Walnut Avenue and Alamitos Avenue and approximately 90 square feet of City property at the southwest corner of 20th Street and Alamitos Avenue; and

WHEREAS, in order to widen the street located at and near the intersection of Walnut Avenue, 20th Street and Alamitos Avenue, it is appropriate at this time to declare this area as additional public street;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That the real property hereinafter described is hereby set apart and dedicated for public street purposes. Said real property is located in the City of Long Beach, County of Los Angeles, State of California, as shown on the attached

1 Exhibit "A" and is more particularly described as follows:

2 That portion of Lot 120 of the American Colony Tract, in the City of Long
3 Beach, County of Los Angeles, State of California, as per map filed in Book 19,
4 Pages 89 and 90, of Miscellaneous Records in the Office of the County Recorder
5 of Los Angeles County, described as follows:

6 BEGINNING at the intersection of the Northwestern right of way line of
7 Alamitos Avenue, 60 feet wide, as shown on a Record of Survey filed in Book 188,
8 Pages 3 through 6, inclusive, of Records of Survey and the Southwesterly line of
9 20th Street, 50 feet wide, as shown on said Record of Survey; thence along the
10 Northwestern right of way line of said Alamitos Avenue, South 53°12'00" West
11 99.52 feet to the point of intersection of said line with the East right of way line of
12 Walnut Avenue, 60 feet wide, as shown on said Record of Survey; Thence along
13 said East right of way line North 00°00'13" East 57.99 feet to a point; Thence
14 leaving said East right of way line South 45°04'46" East 14.65 feet; Thence North
15 89°54'45" East 21.90 feet to the beginning of a tangent curve concave North
16 having a radius of 95.00 feet; Thence Easterly and Northeasterly along said curve
17 through a central angle of 29°31'26" a distance of 48.95 feet to a point on the
18 Southwesterly line of said 20th Street, a radial line to said point bears South
19 29°36'42" East; Thence along said Southwesterly right of way line, being non-
20 tangent to last described curve, South 52°19'20" East 0.77 feet to the POINT OF
21 BEGINNING.

22 The above described parcel of land contains 1,673 square feet, more or
23 less.

24 Section 2. That the real property hereinafter described is hereby set
25 apart and dedicated for public street purposes. Said real property is located in the City of
26 Long Beach, County of Los Angeles, State of California, as shown on the attached
27 Exhibit "B" and is more particularly described as follows:

28 That portion of Parcel 2, in the City of Long Beach, County of Los Angeles,

1 State of California, as per of Parcel Map No. 24543, filed in Book 276, Pages 45
2 through 47, inclusive, of Parcel Maps in the Office of the County Recorder of Los
3 Angeles County, described as follows:

4 BEGINNING at the centerline intersection of Alamitos Avenue, 60 feet wide,
5 and 20th Street, 50 feet wide, as shown on a Record of Survey filed in Book 188,
6 Pages 3 through 6, inclusive, of Records of Survey; Thence along the centerline of
7 said Alamitos Avenue, South 52°19'20" East 41.19 feet to a point; Thence leaving
8 said centerline, at right angles, South 37°40'40" West 15.00 feet to a point on the
9 Southwesterly right of way line of said 20th Street and the TRUE POINT OF
10 BEGINNING; Thence along said Southwesterly right of way line North 52°19'20"
11 West 14.22 feet to the intersection of said Southwesterly right of way line with the
12 Southeasterly right of way line of said Alamitos Avenue; Thence along said
13 Southeasterly right of way line South 53°12'00" West 13.09 feet; Thence leaving
14 said Southeasterly right of way, South 87°45'35" East 21.75 feet to the TRUE
15 POINT OF BEGINNING.

16 The above described parcel of land contains 90 square feet, more or less.

17 Section 3. The City Clerk shall forward, without delay, certified copies of
18 this Resolution to the Board of Supervisors of the County of Los Angeles; the State Board
19 of Equalization, Sacramento, California; and to the Recorder of said Los Angeles County
20 for recordation.

21 Section 4. This resolution shall take effect immediately upon its adoption
22 by the City Council, and the City Clerk shall certify to the vote adopting this resolution.

LONG BEACH, CALIFORNIA

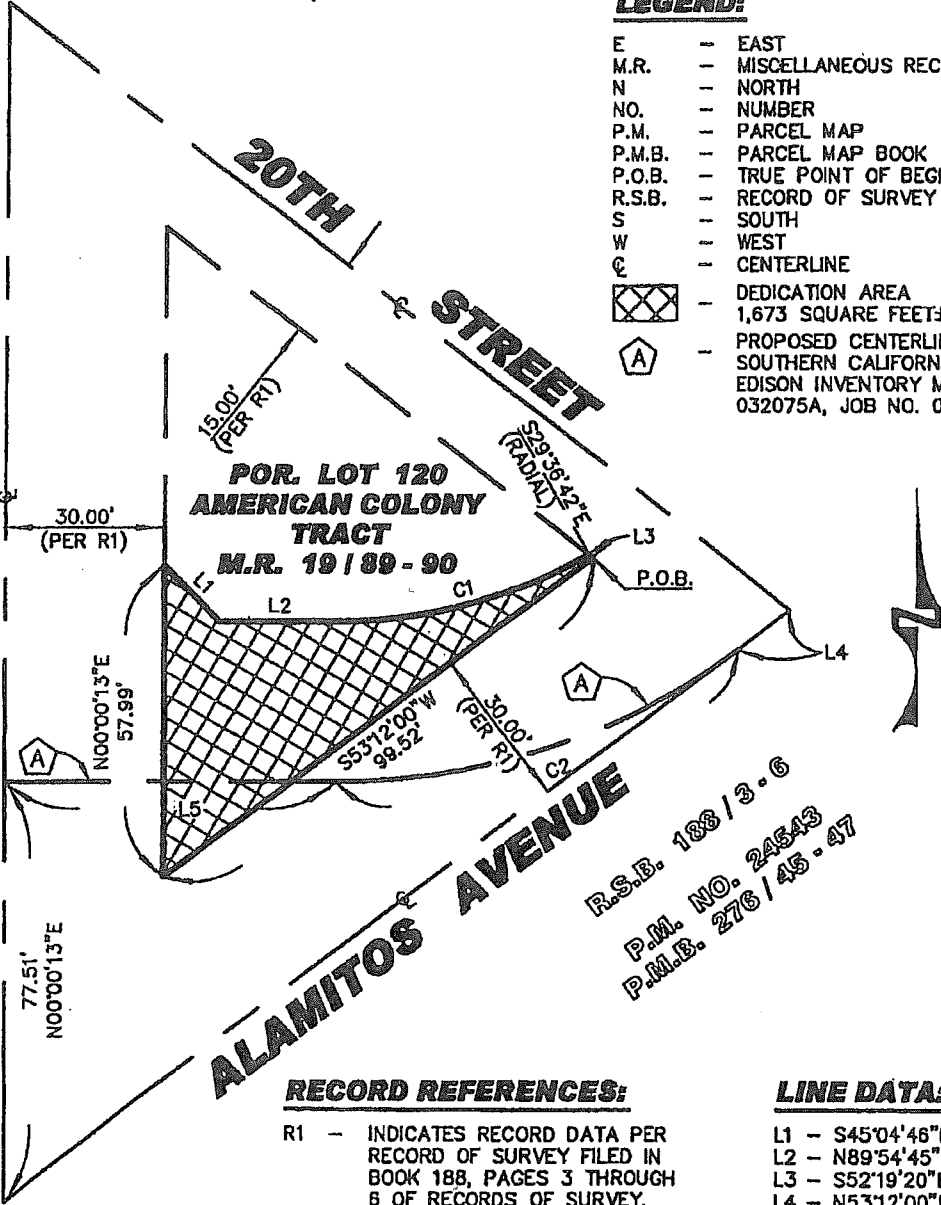

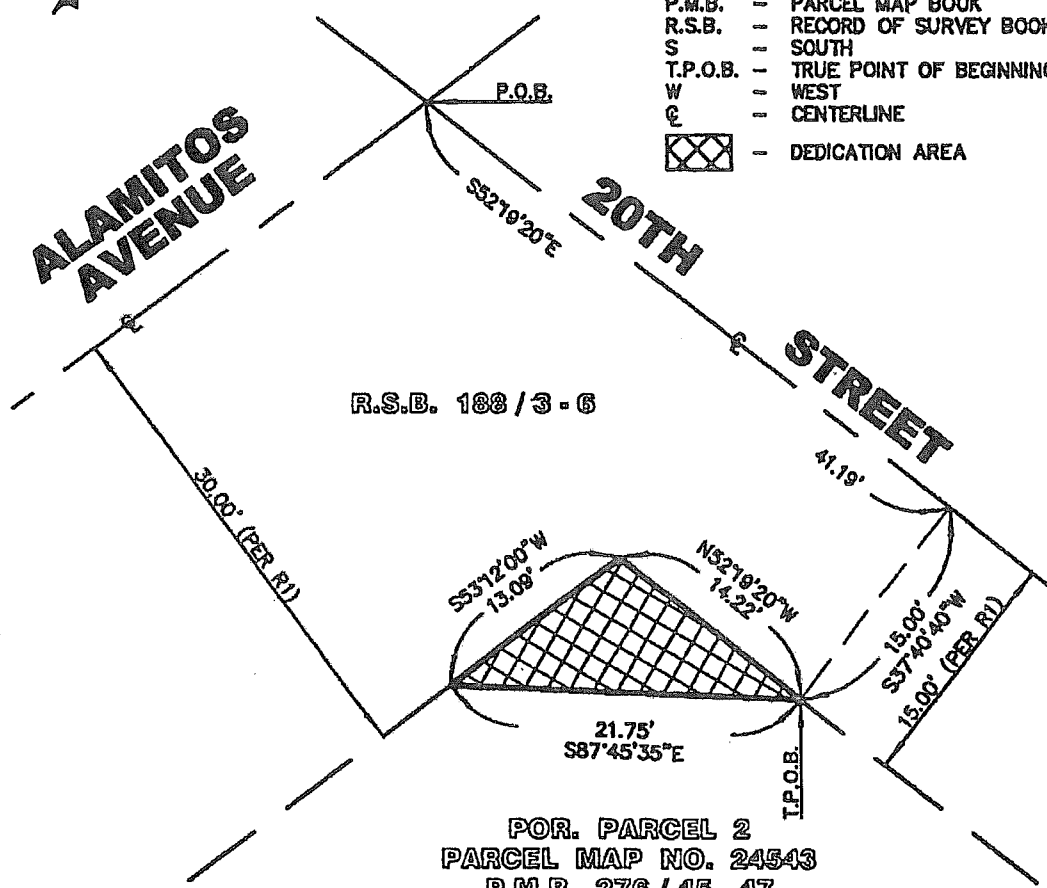
