

1 FIRST AMENDMENT TO PERMIT NO. 29258

3 THIS FIRST AMENDMENT TO PERMIT NO. 29258 is made and entered,
4 in duplicate, as of April 14, 2008, for reference purposes only, pursuant to a minute order
5 adopted by the City Council of the City of Long Beach at its meeting on August 2, 2005,
6 by and between THE CITY OF LONG BEACH, a Municipal corporation ("City") and MEL-
7 O-DEE ICE CREAM ("Permittee").

8 WHEREAS, City granted Permittee permission to sell ice cream products
9 from mobile ice cream vehicles at certain locations; and

10 WHEREAS, the parties desire to amend this permit by extending the term;

11 NOW, THEREFORE, in consideration of the mutual terms and conditions in
12 Permit No. 29258, the parties agree as follows:

13 1. Section 1 of Permit No. 29258 is hereby amended in its entirety to
14 read as follows:

15 "1. The initial term of this Permit shall commence on August 3, 2005 and
16 shall terminate on July 31, 2008. The first extended term of this Permit shall commence
17 on August 1, 2008 and shall terminate on July 31, 2009. This Permit may be executed
18 for one (1) additional one year term at the sole discretion of the City Manager, provided
19 Permittee shall have notified the Director of the Department of Parks, Recreation and
20 Marine of the City of Long Beach ("Director"), prior to April 1, 2009. Permittee
21 acknowledges and agrees that nothing contained in this Permit shall vest in it any right to
22 extend the term."

23 2. Except as expressly stated herein, all of the terms, covenants, and
24 conditions of Permit No. 29258 are ratified and confirmed and shall remain in full force
25 and effect.
