RECOMMENDATION:

Receive the application of David Gomez Cisneros, dba Dave's Family Mexican Restaurant, for an original application of an Alcoholic Beverage Control (ABC) license, at 1538 East 4th Street; submit a Public Notice of Protest to ABC; and, direct the City Manager to withdraw the protest if a Conditional Use Permit Exemption (CUPEX) is granted. (District 2)

DISCUSSION

It is City Council policy to review applications for ABC licenses to determine if a basis for protest against the issuance of the license exists. The attached application lists the possible bases for protest.

TIMING CONSIDERATIONS

The Department of Alcoholic Beverage Control received the above application on September 2, 2020. The applicant is still in the planning stages, and has not yet received a CUPEX. Provided the Planning Commission approves the CUPEX, the recommendation includes a request to direct the City Manager to withdraw the Public Notice of Protest. City Council action is requested on October 20, 2020, to respond to the Department of Alcoholic Beverage Control by the October 22, 2020 due date.

There is no fiscal impact associated with this recommendation.
