With the close of the candidate nomination period on January 15, 2010, the City Clerk is required to submit the attached resolution for adoption pursuant to City Charter Section 1907 which serves to certify list of candidates who were duly nominated, as well as the order in which their names will appear on the official ballot.

Also included in the recommended resolution is a listing of candidates for contests in the Long Beach Unified School District and the Long Beach Community College District as certified by the Los Angeles County Registrar-Recorder/County Clerk. Candidates for the foregoing contests are listed in the order in which they will appear on the official ballot.

## TIMING CONSIDERATIONS

Approval of the recommended action at this time will allow the City Clerk Department to prepare the official ballot, sample ballot and ballot pamphlet.

A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH DESIGNATING THE BALLOT  
LISTING OF THE CANDIDATES WHICH HAVE BEEN  
NOMINATED FOR THE CITY'S PRIMARY NOMINATING  
ELECTION ON TUESDAY, APRIL 13, 2010

WHEREAS, in accordance with the Long Beach City Charter, the City Council has called a municipal primary nominating election to be held in the City of Long Beach on April 13, 2010, for the City Council offices in Council Districts One, Three, Five, Seven, and Nine, and for the offices of Mayor, City Attorney, City Auditor, and City Prosecutor, and for offices of the Board of Trustees of the Long Beach Community College District and Board of Education of the Long Beach Unified School District; and

WHEREAS, in accordance with City Charter Section 1907, the City Clerk has submitted to the City Council a certified list of the candidates which have been duly nominated as required by law for the elective offices to be voted on at said election, and the names are listed for each such office in the order of the randomized alphabet selected by the Secretary of State in a drawing held on January 21, 2010, pursuant to California Elections Code Section 13112.
