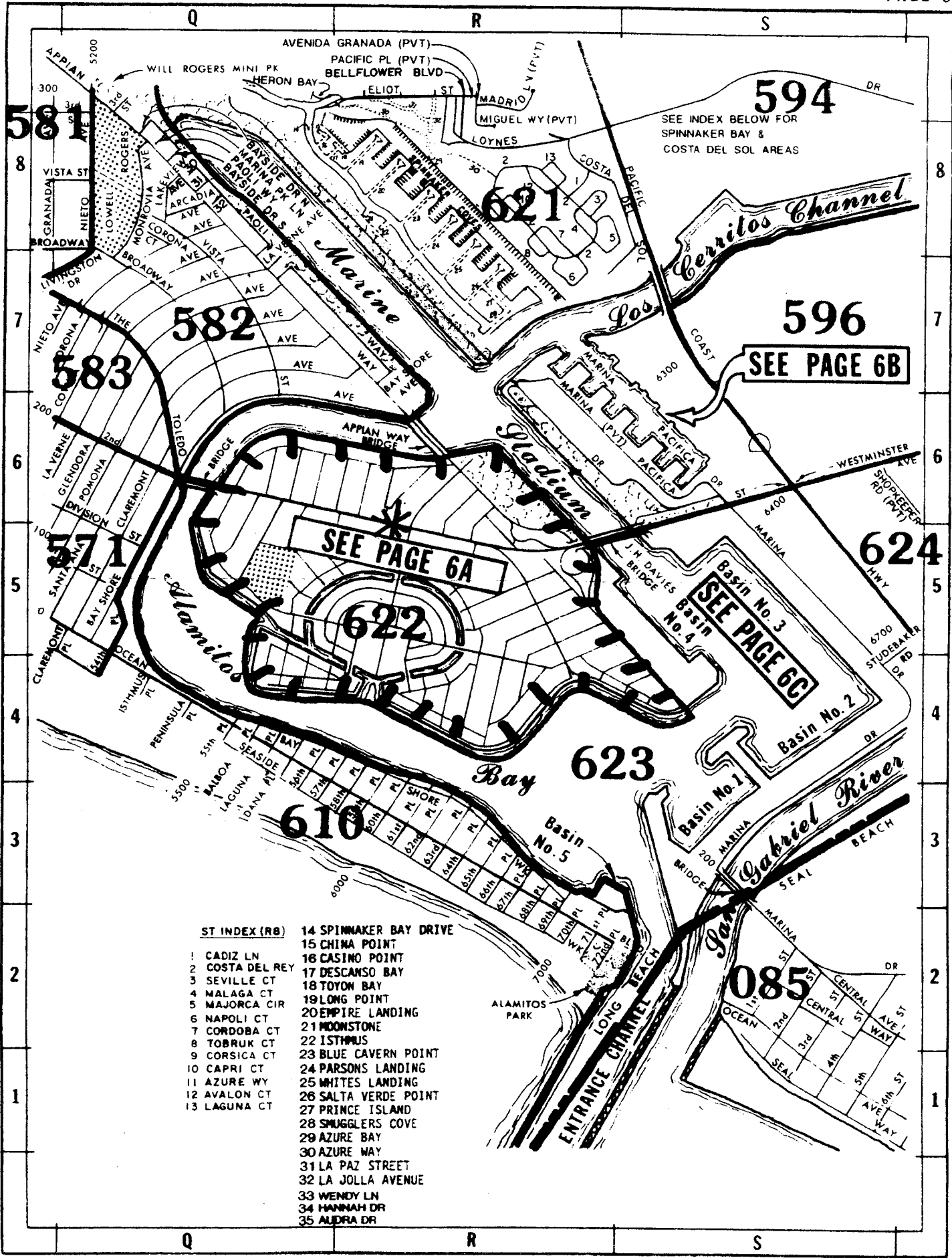

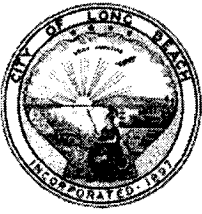

Subject: **ABC LICENSE W/ CONDITIONS – KC Branaghans at 5734 East 2nd Street**

I am submitting the following conditions for your consideration for an original application of an On-Sale Beer and Wine license for a bonafide eating place license.

1. Due to the proximity of residences, all door(s) and windows shall be kept closed at all times, except in cases of emergency and to permit deliveries. Said door(s) is not to consist solely of a screen or ventilated security door. Sound shall not be audible within fifty feet (50') from the exterior of the premises in any direction.
2. Patrons under twenty-one (21) years of age shall not be permitted to enter nor to remain on the premises after the restaurant (food services) portion of the establishment has closed. Private functions not open to the public are exempt from this condition.
3. The permittee shall not allow employees to discard trash or bottles into the outside dumpsters between the hours of 10 p.m. and 7 a.m.
4. There shall be no "queue" allowed after 9 p.m. Sunday through Wednesday nights, and 11 p.m. Thursday through Saturday nights. Queue is defined as persons awaiting entry after the business is at capacity.
5. Security guards must be identifiable as "KC Branaghans employees." Should the permittee's operations give rise to a substantial increase in complaint/calls for police service, or trash left in the parking lot, the permittee shall increase security staff or make other changes to the premises or operation as the Chief of Police determines are necessary to protect the safety of the public.
6. The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside any of the entrance/exit doors and the parking lot, at all times while open for business.
7. Signs reminding patrons to exit the business quietly and to be respectful of the neighborhood should be posted inside and outside the establishment.

8. Current occupancy loads shall be posted at all times and the permittee shall have an effective system to keep count of the number of occupants present at any given time and provide that information to public safety personnel upon request. (LBMC section 18.48.320)
9. The permittee agrees to reimburse the City whenever excessive police services, as determined by the Chief of Police, are required as the result of any incidents or nuisance activity in connection with the permittee's operations.
10. The quarterly gross sales of food shall not be less than fifty (50%) percent of total gross food and alcohol sales for the same period. The permittee shall keep separate records that reflect the gross sales of food and alcohol. Quarterly gross food and alcohol sales records along with quarterly State Board of Equalization Sales and Use Permit records shall be provided to the City of Long Beach.
11. KC Branaghans, its promoters, or agents shall not distribute any advertising matter such as signs, posters, or promotional cards in or upon any public property or in or on any vehicle in the City of Long Beach. Distribution of any advertising matter upon private property shall adhere to the following guidelines: By placing the same matter in a receptacle, clip, or other device designed or intended to receive advertising matter. The permittee shall keep all promoter contracts including names, addresses, and phone numbers on file at all times and must be available for inspection at anytime.
12. The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances, and stated conditions. In the event of a conflict between the requirements of this permit your conditional use permit or your Alcoholic Beverage Control license the more stringent regulation shall apply.
13. Persons under eighteen (18) years of age shall not be permitted to enter or to remain on the premises after 10 p.m. unless accompanied by a parent or legal guardian.
14. The establishment shall remain in compliance with all applicable sections of the Long Beach Noise Ordinance (LBMC Chapter 8.80).

In the event that any of the recommended conditions attached to any permit or license is in conflict the permittee shall adhere to the strictest of the applicable conditions.
