1 FIRST AMENDMENT TO AGREEMENT NO. 34316

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34316 is made and
4 entered, in duplicate, as of December 7, 2016, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 3, 2015, by and between MACIAS GINI & O'CONNELL LLP, a California limited
7 liability partnership formerly known as INTELLIBRIDGE PARTNERS LLC, a California
8 limited liability company ("Consultant"), with a place of business at 3000 S Street, Suite
9 300, Sacramento, California 95816, and the CITY OF LONG BEACH, a municipal
10 corporation ("City").

11 WHEREAS, City requires specialized services requiring unique skills to be
12 performed in connection with as-needed professional and technical services ("Project");
13 and

14 WHEREAS, City and Consultant entered into Agreement No. 34316 (the
15 "Agreement") whereby Consultant agreed to provide these services; and

16 WHEREAS, City and Consultant desire to increase the total not to exceed
17 amount and extend the term;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
19 conditions in the Agreement and this Amendment, the parties agree as follows:

20 1. Section 1.A of the Agreement is hereby amended to read as follows:

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay for
24 these services in the manner described below, not to exceed Four Hundred
25 Thousand Dollars (\$400,000), at the rates or charges shown in Exhibit "B".

26 2. Section 2 of the Agreement is hereby amended to read as follows:

27 "2. TERM. The term of this Agreement shall commence at midnight on
28 January 1, 2016, and shall terminate at 11:59 p.m. on January 22, 2018, unless sooner

1 terminated as provided in this Agreement, or unless the services or the Project is
2 completed sooner.”

3 3. Except as expressly modified herein, all of the terms and conditions
4 contained in Agreement No. 34316 are ratified and confirmed and shall remain in full force
5 and effect.
