

ORDINANCE NO. ORD-20-0021

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SECTION 2.06.060, AND SUBSECTIONS 2.18.050.D AND 2.63.030.A, ALL RELATING TO COMMISSION COMPENSATION

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 2.06.060 of the Long Beach Municipal Code is amended to read as follows:

Members of boards, committees, and commissions of the City shall receive such compensation, if any, as may be fixed and prescribed by the City Council in the Salary Resolution of the City. Members of any board, commission, or committee compensated by the City Council in the Salary Resolution shall be ineligible to receive compensation, including, but not limited to, stipends, unless and until:

1. A Form 700 is filed with the City Clerk: (1) within 30 days of assuming office, (2) every year thereafter by April 1st, and (3) within 30 days of leaving office; and

2. Ethics training required pursuant to California Government Code Section 53234 et seq. is complete and current within the time period specified therein.

Section 2. Subsection 2.18.050.D of the Long Beach Municipal Code is amended to read as follows:

D. The members of advisory bodies shall receive no

1 compensation, including, but not limited to, any stipend, for the performance
2 of their official duties unless compensation is expressly provided by the City
3 Council. Members of any advisory body expressly compensated by the City
4 Council shall be ineligible to receive compensation unless and until:

5 1. A Form 700 is filed with the City Clerk: (1) within 30
6 days of assuming office, (2) every year thereafter by April 1st, and (3) within
7 30 days of leaving office; and

8 2. Ethics training required pursuant to California
9 Government Code Section 53234 et seq. is complete and current within the
10 time period specified therein.

12 Section 3. Subsection 2.63.030.A of the Long Beach Municipal Code is
13 amended to read as follows:

14 A. A Cultural Heritage Commission is created by this Chapter
15 whose purpose shall be to recognize, protect and promote the retention,
16 maintenance and use of Landmarks and Landmark Districts in the City in
17 accordance with this Chapter. Said Commission shall consist of seven (7)
18 members who are residents of the City who have manifested a knowledge
19 and interest in the preservation of the City's cultural heritage.

21 Section 4. The City Clerk shall certify to the passage of this ordinance by
22 the City Council and cause it to be posted in three (3) conspicuous places in the City of
23 Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the
24 Mayor.


