AMENDMENT TO THE CONTINUUM OF CARE PROGRAM GRANT AGREEMENT

This Amendment to Grant Agreement is made by and between the United States Department of Housing and Urban Development ("HUD") and the City of Long Beach CoC, (the "Recipient").

RECITALS

- 1. HUD and the Recipient entered into a Grant Agreement dated July 25, 2016, having Grant No. CA0000U9D061503 (the "Grant Agreement").
- 2. The parties are desirous of amending the Grant Agreement to change the component type of one of the sub-grants under the Agreement (sub-grant number CA0650U9D061508) from Transitional Housing (TH) to Permanent Housing (PH): Rapid-Rehousing (RRH).
- 3. In addition to the change in component type, the budget will be modified for sub-grant CA0650U9D061508 by eliminating both the Leasing and Operating budget line items and moving those funds to create a new budget line item for Rental Assistance. Additionally, Supportive Services will be slightly reduced, and those funds will also be moved to Rental Assistance.
- 4. HUD has determined that the change is necessary to make a technical correction to the grant information and to ensure that the priorities established under the Notice of Funding Availability under which the grant was awarded are met.

AGREEMENTS

- 1. Sub-grant CA0650U9D061508 is amended from TH to PH-RRH.
- 2. The revised budget for sub-grant CA0650U9D061508 is:
