NUMBER OF MEMBERS OF THE BIXBY KNOLLS AREA  
ADVISORY BOARD PURSUANT TO ORDINANCE NO.  
C-6646

The City Council of the City of Long Beach resolves as  
follows:

Section 1. Pursuant to Section 6 of Ordinance No.  
C-6646, adopted September 19, 1989, the number of members of the  
Bixby Knolls Area Advisory Board is hereby determined to be  
eleven (11) voting members who need not be residents of the City  
of Long Beach but each of whom must own or operate a business  
within the Bixby Knolls Area as described in Ordinance No.  
C-6646 and be subject to any and all assessments levied  
thereunder. Additionally, the Long Beach City Manager or his  
designee may fully participate as a member of said Board but  
shall have no vote and shall not be counted for purposes of  
establishing a quorum. In appointing voting members to the  
Advisory Board, the Mayor shall use best efforts to assure that  
the Board membership is reflective of the geographic and  
business character of the Area. In making initial appointments,  
the Mayor shall, and is authorized to, provide for staggered  
terms so that the terms of six members will expire in even  
numbered years and the terms of five members will expire in odd
