AN ORDINANCE AMENDING ORDINANCE NO.
C-3600, KNOWN AS THE LONG BEACH MUNICIPAL
CODE, BY AMENDING ITEM (b) OF SUBSECTION (11) OF
SECTION 3410.121, ITEMS (a) AND (b) OF SUBSECTION
(45) OF SECTION 3410.121, SUBSECTION (62) OF
SECTION 3410.131; BY ADDING SUBSECTION (61)
AND ITEM (a) TO SECTION 3410.120, SUBSECTIONS
(605) AND (606) TO SECTION 3410.127; AND BY
REPEALING SUBSECTION (41) OF SECTION 3410.122,
ALL RELATING TO TRAFFIC CONTROL

The City Council of the City of Long Beach ordains as
follows:

Section 1. That Ordinance No. C-3600, as amended,
known as the Long Beach Municipal Code, is amended by amending
Item (b) of Subsection (11) of Section 3410.121 to read:

(b) Those portions of the street within the City,
between the Union Pacific Railroad overcrossing near
Fifty-third Street and San Antonio Drive, forty-five
miles per hour.

Sec. 2. That Ordinance No. C-3600 is further amended by
amending Items (a) and (b) of Subsection (45) of Section 3410.121
to read:

(a) Park Avenue to Pacific Coast Highway, forty miles

Sec. 3. That Ordinance No. C-3600 is further amended
by amending Subsection (62) of Section 3410.131 to read:

(62) At both curbs of Clark Avenue between Pacific
Coast Highway and Atherton Street; and at the east curb
between Walton Street and a point three hundred thirty
feet north of Twenty-eighth Street.

Sec. 4. That Ordinance No. C-3600 is further amended
by adding Subsection (61) and Item (a) to Section 3410.120 to
read:

(61) Monlaco Road

(a) Clark Avenue to Palo Verde Avenue, thirty
miles per hour.

Sec. 5. That Ordinance No. C-3600 is further amended
by adding Subsections (605) and (606) to Section 3410.127 to
read:

(605) Nieto Avenue at Division Street.


(606) Twenty-third Street at its intersection
with Roycroft Avenue.

by repealing Subsection (41) of Section 3410.122.


